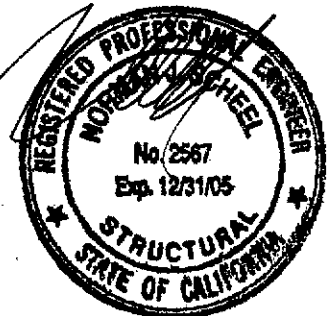
To Whom It May Concern:

This letter is to clarify the following comments:

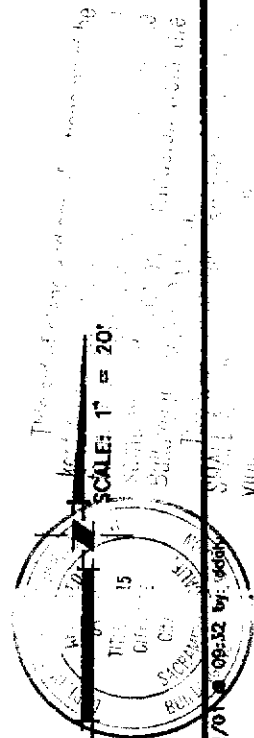
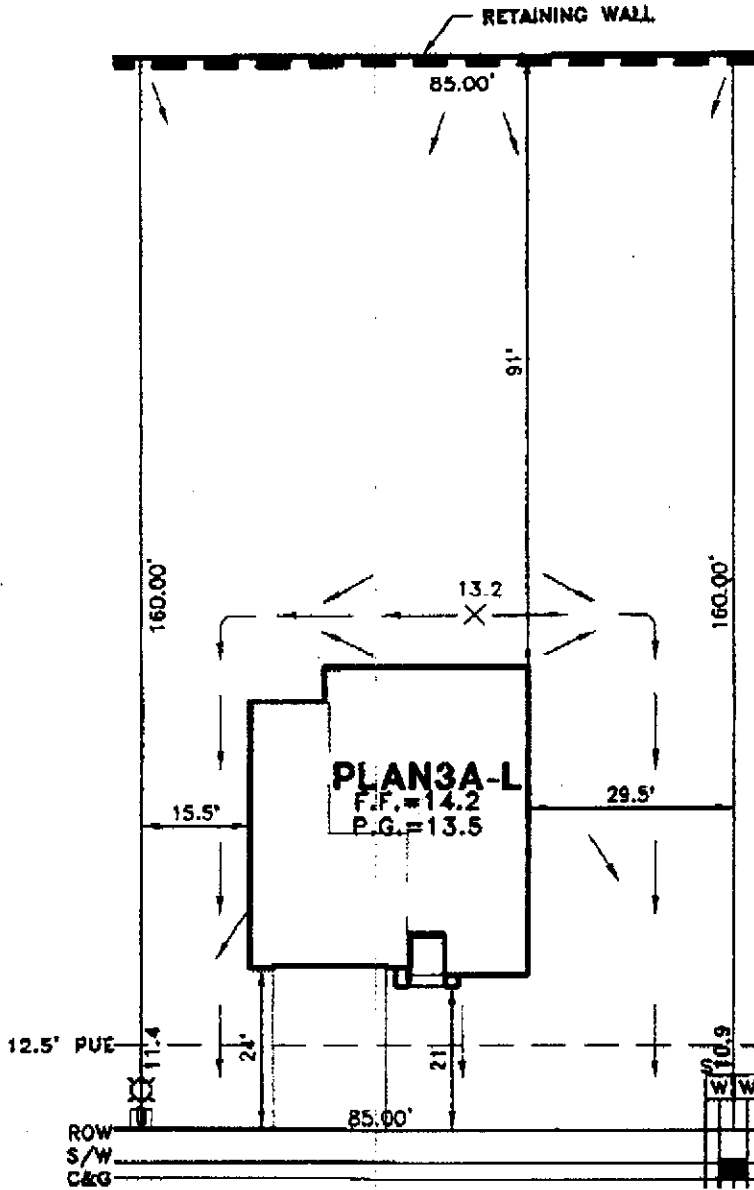
1. Walls hanging over the foundation – if the walls hang over the concrete more than ½" both MAS anchors and HPAHD-22-2P holdowns will require repairs. For the MAS anchors, anchor bolts should be installed per the specifications on the plans using Simpson Epoxy. For the holdowns, a HTT22 epoxy fix will be required. See sketches with this letter.
2. Spalling around HPAHD22 holdowns – if the spall is less than 4" no repair is required. If the spall exceeds 4" install HTT22 epoxy fix.
3. See alternate detail with this letter for TJI rafter at overhang.
