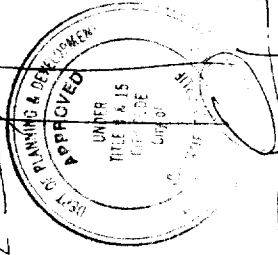
REAR ELEVATION

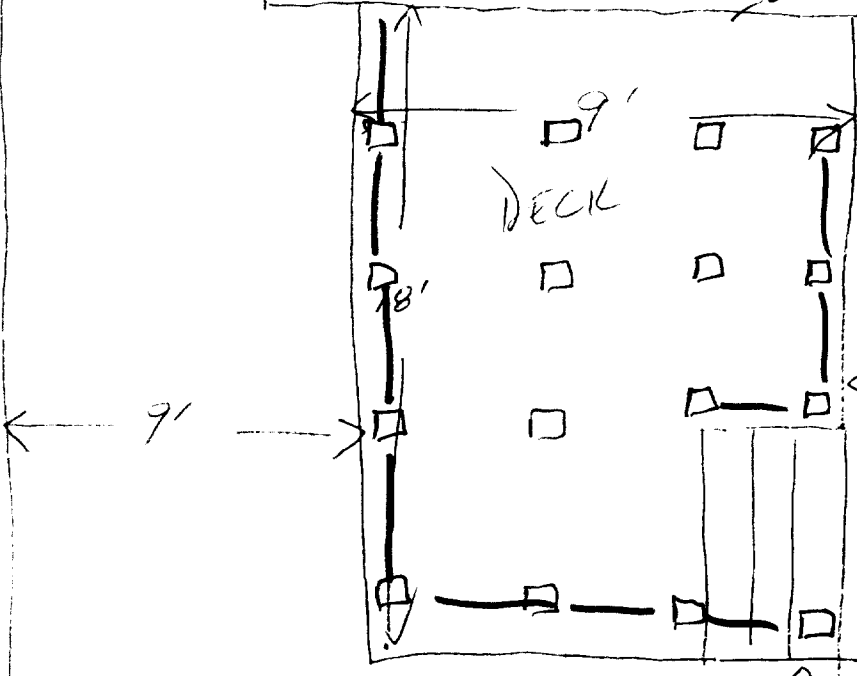

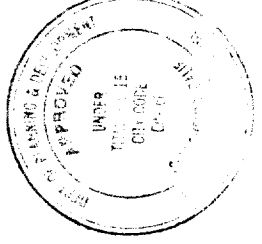
