SUBJECT: Approval of Agreements with Camellia City Center (Catholic Social Services) and Stanford Settlement, Inc.

SUMMARY

The City Council agreed to provide financial assistance to the Stanford Settlement for the Summer Day Camp Program and to provide for operational costs at the Camellia City Center (Catholic Social Services) for fiscal year 1987-88. Approval of an agreement with each agency is necessary.

BACKGROUND INFORMATION

The City Council provided continued funding for both of these nonprofit agencies in the FY 1987-88 operating budget of the Department of Parks and Community Services, Recreation Division. Agreements are necessary with both of these organizations setting forth the terms by which agreement with each organization is to be monitored and enforced.

The agreements have been executed by both agencies and are on file in the City Clerk's Office.

FINANCIAL DATA

The City Council appropriated, in the FY 1987-88 operating budget, the sum of \$10,000 to the Stanford Settlement, Inc. and \$67,425 to Catholic Social Services for the Camellia City Center operation.
