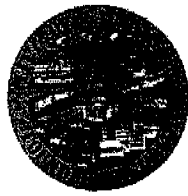



COMMENTS: Lot is 5400 SF per MetroScan map. Proposed total lot coverage is 1930 / 5400 = under 36%, which meets the maximum 40% lot coverage requirement. Applicant intends to substitute the required rear lot by having a greater interior side setback, which is allowable on corner lots in R-1 zone. Measurement is taken from the front setback to the rear of the lot. Minimum setback at the sides and rear shall be at least 5'. Required rear setback area is 15' x 60' = 900 SF. The substituted area is 1000 SF. Proposed front is the average of the adjacent neighbors, which is 21 ft, street-side 12 1/2 ft, rear 5 ft and the interior side 17 ft. Proposed setbacks and lot coverage are okay. All fencing shall be no greater than 6 ft height. Fencing at the street-side setback area shall have a 5' setback if it is taller than 4 ft in height. . Minimum 20 ft driveway is required. No other planning entitlement apparent.



STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Windows at north and west lower elevations shall be single hung with decorative trim, sills, and shutters as indicated on approved drawings. In addition, all windows at upper north and west elevations shall be ½ gridded horizontal sliders with decorative trim, sills, and shutters. Windows at south and east elevations shall be ½ gridded horizontal sliders with decorative trim and sills at minimum.
2. Front entry door and garage door shall have decorative raised panel design as indicated on approved drawings.
3. 7" fiber cement horizontal lap siding shall be provided at north and west upper elevations as indicated on approved drawings.
4. A 1x6 trim board shall be provided at north and west elevations to transition to 2nd material as shown on approved plans.
5. Porch elements at north and west elevations shall have decorative columns with a minimum width of 6"x6" with built out bases as indicated on approved drawings.
6. All woodwork shall be smooth finish, no rough sawn.
7. Six (6) foot high wood fences at sides and rear shall be provided.
8. Front yard landscaping (including lawn, shrubs, and a minimum of one tree) and automatic irrigation shall be provided.
9. Roof pitch shall be a 6/12 as indicated on approved drawings.
10. Roofing shall be a minimum 30-year laminated dimensional composition shingle.
11. Gutters and downspouts shall be provided.
12. Decorative light fixtures shall be provided at front entry and garage as indicated on approved drawings.
13. No roof-mounted mechanical equipment is allowed.
14. All other notes and drawings on the final plans as submitted by the applicant are deemed conditions of approval. Any changes to the final set of plans stamped by Design Review staff shall be subject to review and approval prior to any changes.
15. No building permit shall be issued until the expiration of the 10-day appeal period. If an appeal is filed, no permit shall be issued until final approval is received.
16. The applicant and the owners of all properties adjoining the subject property have the right to appeal this decision to the Design Review and Preservation Board. Appeals must be filed within 10 days of the staff action.

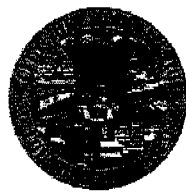

BUILDING CODE REQUIREMENTS

- B-1 Smoke detector location within dwelling units. In dwelling units, a detector shall be installed in each sleeping room and at a point centrally located in the corridor or area giving access to each separate sleeping area. When the dwelling unit has more than one story and in dwellings with basements, a detector shall be installed on each story and in the basement. In dwelling units where a story or basement is split into two or more levels, the smoke detector shall be installed on the upper level except that, when the lower level contains a sleeping area, a detector shall be installed on each level. When sleeping rooms are on an upper level, the detector shall be placed at the ceiling of the upper level in close proximity to the stairway. In dwelling units where the ceiling height of a room open to the hallway serving the bedrooms exceeds that of the hallway by 24 inches (610 mm) or more, smoke detectors shall be installed in the hallway and in the adjacent room. Detectors shall sound an alarm audible in all sleeping areas of the dwelling unit in which they are located. In new construction, required smoke detectors shall receive their primary power from a commercial source and have a battery back up. 2001 CBC, Section 310.9.1.
- B-2 When alteration, repairs, or additions having a value in excess of \$1,000 are made, provide an approved smoke detector to protect existing sleeping rooms. The detector may be battery operated as per 2001 CBC, Section 310.9.1.2.
Exception: Repairs to the exterior surfaces of a Group R occupancy are exempt from the requirements of this section.
- B-3 Emergency escape and rescue. Basements in dwelling units and every sleeping room below the fourth story shall have at least one operable window or door approved for emergency escape or rescue that shall open directly into a public street, public way, yard, or exit court. Escape or rescue windows shall have a minimum net clear openable area of 5.7 square feet / 821 SQ. inches. The minimum net clear openable height dimension shall be 24 inches. The minimum net clear openable width dimension shall be 20 inches. Emergency escape or rescue windows shall have a finished sill height not more than 44 inches above the floor. 2001 CBC, Section 310.4.
- B-4 All Group U occupancies attached to Group R, Division 3 occupancies shall be separated by materials approved for one-hour fire-resistive construction. The separation may be limited to the garage side only and requires a self-closing, tight fitting solid wood door 1 3/8 inches in thickness or a self-closing, tight fitting door having a fire protection rating of not less than 20 minutes. CBC, Section 302.4, Exception 3. **Note:** All members supporting such separation shall be equivalent fire-resistive construction as per 2001 UBC, Section 302. All electrical outlet boxes on opposite sides of the wall shall be separated by a horizontal distance on not less than 24 inches per 2001 CBC 709.7, Exception 1

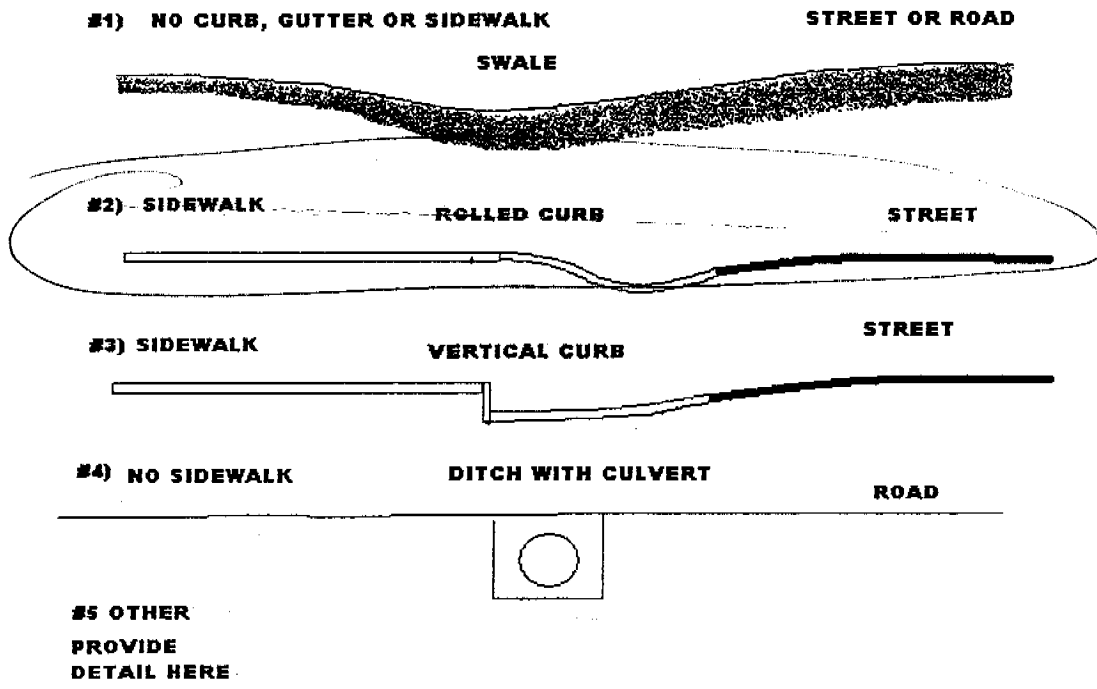
