Summary: This report is the annual summary of Small Business and Very Small Business utilization for 2005.

Committee/Commission Action: Informational only

Background Information: City Council approved the implementation of SHRA's Small Business Enterprise Program (SBEP) on April 10, 2001. The Agency continues to recognize the importance of small business to the local economy. The Agency has committed to fostering the growth of the small business sector by strengthening the connection between small businesses and the Agency's contracting opportunities (defined as procurements handled by the Agency's Procurement Division). As a part of the program, to qualify as a small business or very small business, the Agency adopted a two-tiered classification that starts at one-half of the implemented standards set by the State of California's Office of Small Business Certification and Resources (OSBCR) in 2001. To restate, the definitions for those standards are as follows:

Small Business

- A business with 50 or fewer employees and an average annual gross receipts of \$5 million or less over the previous three tax years, or
- a manufacturer with 50 or fewer employees

Very Small Business

- A business with 25 or fewer employees and an average annual gross receipts of \$2.5 million or less over the previous three tax years, or
- a manufacturer with 25 or fewer employees

This report will present program accomplishments, activities, and results for 2005 and program goals for 2006.

PROGRAM ACCOMPLISHMENTS AND ACTIVITIES FOR 2005

- Continued to provide list of SBEP certified sub-contractors to prime contractors, encouraging sub-contracting portions of their work to small business.
- Vendor-Participant in the Sacramento Metro Chamber/City of Sacramento Business Expo in May of 2005. Over 1,000 vendors and businesses participated in this event.
- Vendor-Participant in the State of California, Department of General Services, Resource Exchange series.
- Vendor/Exhibitor at the 2005 Black Expo.

PROGRAM RESULTS

- In 2005, 258 new vendors have been added to the Agency database.
- In 2005, the Agency did business with 314 vendors. Out of those, 41 were small business and 128 were very small businesses.
- Total utilization for the period of January 1, 2005 – December 31, 2005 is as follows:
 - 58 percent of procurement dollars were issued to small business and very small businesses
 - 69 percent of total number of purchase orders and contracts were issued to small business and very small businesses

In the area of construction procurements, the Agency's small business participation increased from 12.3 percent in 2004 to 32.3 percent in 2005. For very small businesses, the participation increased from 28.2 percent in 2004 to 30.9 percent in 2005. Much of the credit for this increase is due to the awards for the rehabilitation of the 5H Homes to prepare them for homeownership. All 5H related awards were made to either small or very small businesses. Through this program, \$1.3 million dollars were awarded to small businesses and \$1.2 million dollars were awarded to very small businesses.

As with past years, this year's results go beyond the program goals. The overall results for the past three years continue to exceed our original goal of 30 percent utilization for small businesses with a sub-set of 15 percent utilization for very small businesses.

PLANS FOR 2006

- Continue outreach to the community through business organizations, chambers, and other activities as they present themselves.
- Hold a "Contractor's Forum" in the fall of 2006 to provide an opportunity for all interested contractors to either learn the bidding process or discuss any obstacles they have regarding the bidding process.
- Meet on a quarterly basis with staff from the City of Sacramento, County of Sacramento, Regional Transit and SMUD to further our joint efforts.
- Conduct additional staff training as needed throughout the year.
- Continue to expand the vendor database and enhance the reporting capabilities.
- Continue to maintain utilization records of small business and very small businesses to match or exceed our current goals.


Overall, staff's goal for 2006 is to continue to increase the outreach to small businesses and very small businesses as well as provide training and assistance to further enhance the participation of these groups in ongoing procurement opportunities.

Financial Considerations: This report is informational only - there are no financial considerations.

Environmental Considerations: This report is for information only regarding an existing program, so no environmental review is required.

Policy Considerations: This report is an annual report to the governing bodies of the status and results since the implementation of the Small Business Enterprise Program adopted on April 10, 2001.


