

MINUTES OF SPECIAL MEETING
HONORABLE CITY COUNCIL OF THE CITY OF SACRAMENTO
APRIL 4 1939.

The Honorable City Council met in Special Session on this date at the hour of 8:05 o'clock P.M., RAY T. COUGHLIN, President Protem of Council presiding and Roll Call answered by the following:

Councilmen Anderson, Arnold, Bidwell, Coughlin, Harry, Kunz, Truesdale, Welsh.

ABSENT: Councilman Monk.

Call for the Meeting was ordered filed.

The purpose of the Meeting being the Canvassing of Absentee Votes of Special Municipal Election held on March 28, 1939.

City Manager presented the following Resolution:

RESOLUTION NO. 651A CITY COUNCIL

DECLARING CANVASS OF ABSENTEE VOTES CAST
AT CONSOLIDATED SPECIAL ELECTION HELD
MARCH 28, 1939.

"WHEREAS, on this day, to wit, Tuesday, the 4th day of April, 1939, at the hour of 8 o'clock P.M., the Council of the City of Sacramento, has met at its usual place of meeting and has canvassed the Absentee Ballots cast at the consolidated special election held in said City of Sacramento on March 28, 1939, as required by law, and the result of such canvass of Absentee Ballots is found to be as hereinafter stated and set forth:

"IT IS HEREBY RESOLVED, DETERMINED AND DECLARED BY the City Council of the City of Sacramento, as follows:

"That all absentee voter ballots have been fully received and canvassed in the time, form and manner required by law, and the result of the absentee vote for and against each of the proposals submitted at said consolidated election is as follows:

ABSENT: Councilman Monk.


