STAFF ACTION AND CONDITIONS OF APPROVAL:

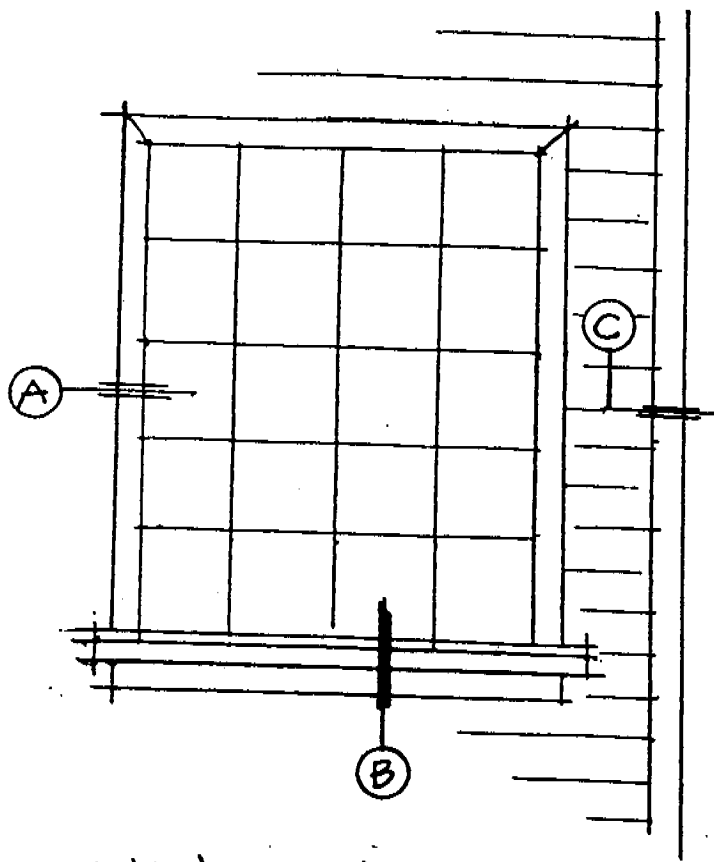
Staff has reviewed the proposed project, and approves it with the following conditions of approval:

2. Provide trim and sills per the attached City detail at all street-facing doors and windows at minimum.
3. The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.

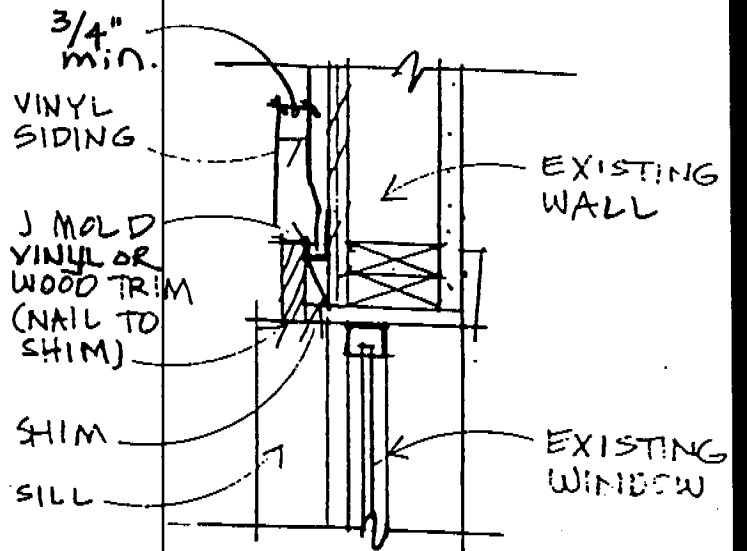

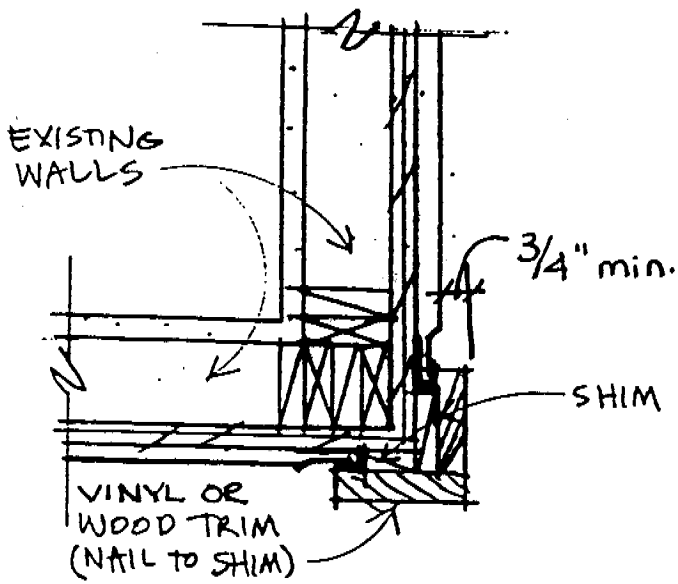
WOOD TRIM DETAILS WITH VINYL SIDING



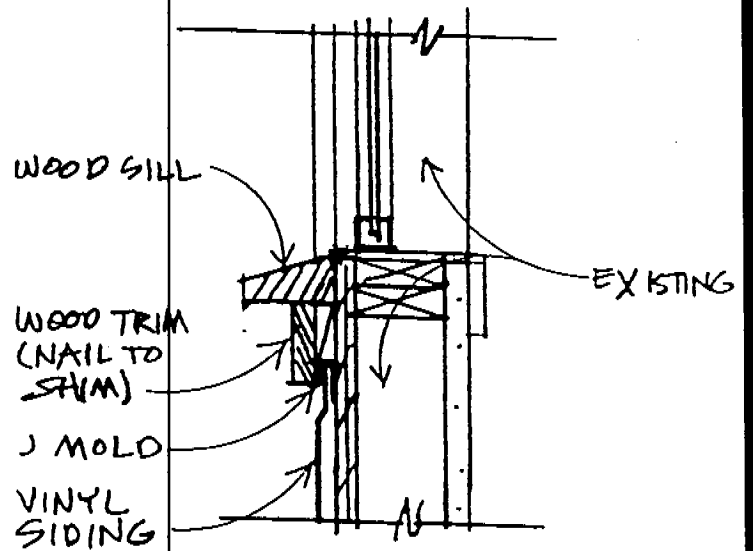
WINDOW ELEVATION



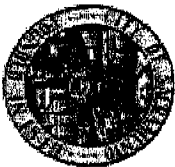
