Description: Defective or lack of weather protection for exterior walls including lack of paint or weathering due to lack of paint or other approved protective covering. 49.10.1008(30)

Comments: Stairs and porch cover at the rear of the property are not properly weatherized, i.e. not painted.

Corrective Action:

Violation: B22 - Building

Description: Hazardous or unsanitary premises: Accumulation of weeds, vegetation, junk, dead organic matter, debris, garbage, offal, rat harborage, stagnant water, combustible materials and similar materials, causing a safety hazard. 49.10.1011

Comments: The interior of unit #4 is full of garbage, debris, cat urine and droppings. Combustible materials were seen around the gas water heater. The unit reeked of cat urine to the extent that it was noticeable in the neighboring unit.

Corrective Action:

Violation: B24 - Building

Description: Inadequate exits. 49.10.1013

Comments: The handrail for the rear stairs does not meet UBC requirements.

Corrective Action:

Violation: P10 - Plumbing

Description: Other

Comments: 1. This list may be partial and does not exclude any code violations which may become apparent during further inspections or during the necessary rehab/repair work.
