

Sacramento, California,

December 18, 1929.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:40 o'clock P.M., President Chenu presiding.

PRESENT: Commissioners Mason, Weisman, and Chenu.
ABSENT : None.

The minutes of the special meeting of December 4th were read and approved as read.

An opinion was received from the City Attorney relative to Ordinance No. 448 recently passed affecting the classifications and ratings established by the Civil Service Board for positions in the City Clerk's office. The ordinance designates the positions as those of Chief Deputy and Deputy instead of Senior Clerk, and the City Attorney advised that under Section 43 of the Charter the Chief Deputy's position was exempt from Civil Service, the Deputy's position being in the classified service. Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the opinion was ordered filed.

A communication was received from Mr. F. N. Evans, Superintendent of Parks, with reference to Mr. Culbertson, a Mechanic in the department, explaining the cause for Mr. Culbertson's leaving the service prior to his last employment. Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the communication was ordered filed.

A communication was received from Mr. Gerald Hahn, an employee in the Engineering Department, requesting a leave of absence for one year. Upon motion by Commissioner Mason, seconded by Commissioner

Weisman, and unanimously carried, Mr. Hahn's request was granted.

A communication was received from Mr. Robert Wakefield, complaining that employees were not being held in their proper classifications and rates in accordance with Civil Service regulations. Mr. Wakefield appeared before the Board. Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the Secretary was instructed to send Mr. Wakefield's communication to the Engineering Department with a letter explaining the Civil Service regulations.

Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the complete file covering the case of Officer J. C. Coyle was referred to the City Attorney for an opinion as to whether he now has rights as to priority and whether his case is comparable to that of Officer Wagner.

The Board next proceeded with the Personal Fitness test for Corporal of Police. Nine candidates were interviewed. Upon completion of this test, the following eligible list was established:

Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the list was ordered posted December 19, 1929, and effective January 1, 1930.

The Board then reviewed the examination papers for Captain in the Fire Department, and opened the envelopes to establish identity. Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the Personal Fitness test for this examination

was set for Friday, January 10, 1930, at seven-thirty o'clock P.M.

There being no further business, the meeting adjourned at 10:00 o'clock P.M. to meet again January 10, 1930, at seven-thirty o'clock P.M.
