**Title:** Prohibit Parking on a Portion of H Street for Street Cleaning

**Location/Council District:** H Street, south side, between 20<sup>th</sup> and 21<sup>st</sup> Streets.

**Recommendation:** Adopt a **Resolution** prohibiting all parking on a portion of H Street from 8:00 a.m. to 11:00 a.m. each Monday to allow for street cleaning.

### Description/Analysis

**Issue:** City street cleaning crews are unable to clean this portion of H Street due to parked vehicles, allowing leaves and other debris to accumulate in the gutter.

**Policy Considerations:** This recommendation is consistent with the City Council's Strategic Plan goal of enhancing sustainability and livability.


**Environmental Considerations:** This proposed resolution is not a project and therefore is exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15061 (b) (3) of the CEQA guidelines.


**Rationale for Recommendation:** Prohibiting all parking from 8 am to 12 noon one day per week will allow City crews unobstructed access to the curb and gutter for street cleaning to remove leaves and other debris.



**Financial Considerations:** The cost to implement the recommended parking regulation is estimated to be \$500.00 for the placement of regulatory signs. Funds are available in the Parking Services Division operating budget.

**Emerging Small Business Development (ESBD):** There are no ESBD considerations associated with the requested action.

**PROHIBIT PARKING ON A PORTION OF H STREET FOR STREET CLEANING**

**BACKGROUND**

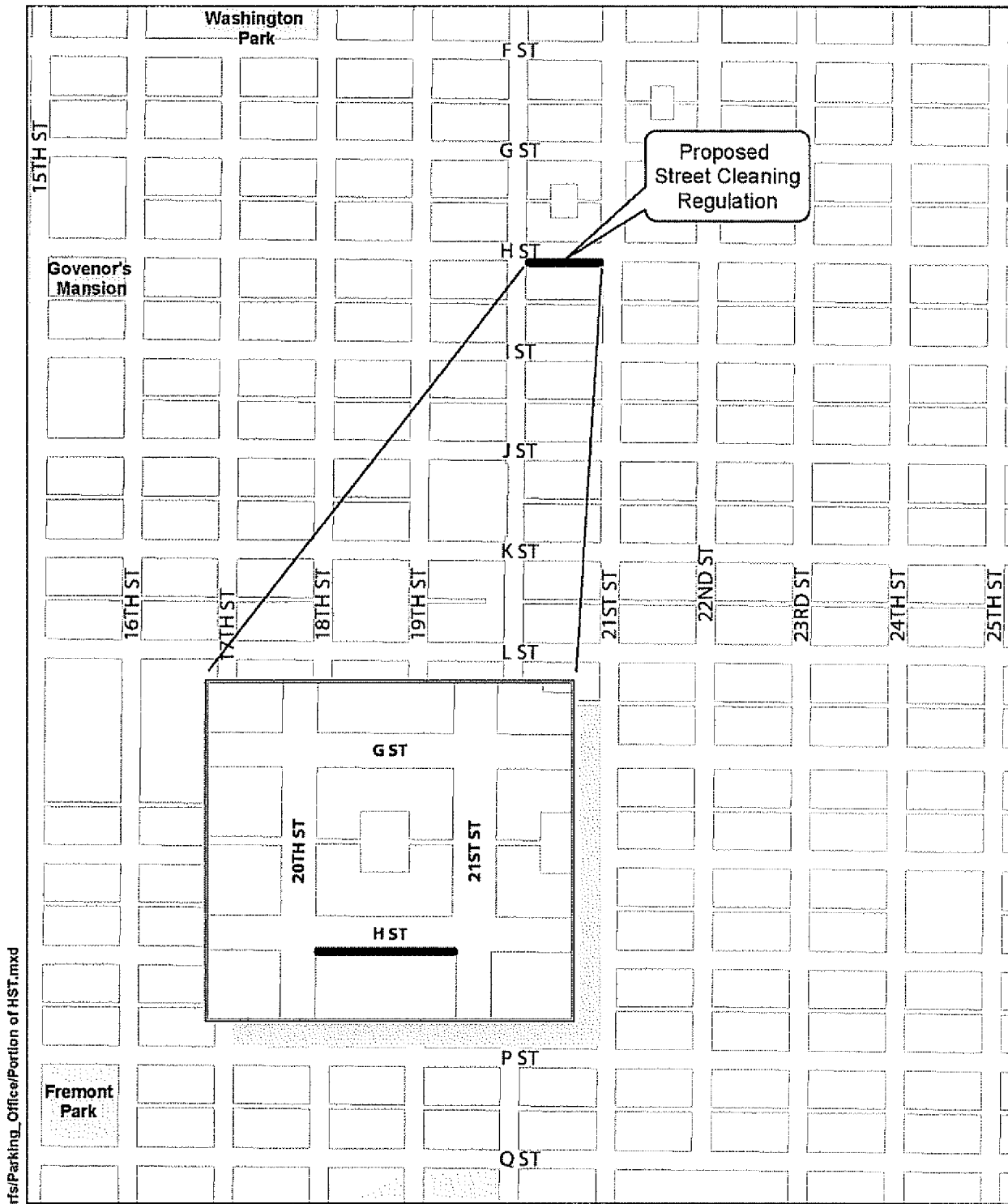
- A. In February of 1992 the City Council approved the Central City Street Cleaning Program. This program was adopted to provide cleaner streets through improved street cleaning, garbage collection and recycling services. Under this program, parking is prohibited from 8:00 a.m. through 12:00 noon, one day each week on alternate sides of the street. This allows City crews unobstructed access to the curb and gutter.
- B. The Parking Services Division received a request to prohibit all parking one day each week on the south side of H Street between 20<sup>th</sup> and 21<sup>st</sup> streets allowing access to the curb and gutter for street cleaning.
- C. A letter outlining the proposal and a comment return card was sent to all of the businesses and residents on the block. No opposition to the proposal has been received.
- D. The parking restriction for this portion of H Street will be reduced to 8:00 a.m. through 11:00 a.m. to provide customer parking for surrounding businesses.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. Prohibit all parking on the south side of H Street from 20<sup>th</sup> to 21<sup>st</sup> Streets each Monday from 8:00 a.m. to 11:00 a.m. for street cleaning.
