I have reviewed the framing installation of the dormers for this project. The size and spacing is quite adequate for the spans. The nailing at the ridge is sufficient as installed. The nailing of the plywood sheathing shall be 8d @ 12" field and 8d @ 6" edge.

All the roof framing meets the standards of the design and engineering and all the changes made are fine with our office. The 2x4 collar ties @ 16" c.c. are adequate as well.
