STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Roofing to be 25-year laminated dimensional composition shingle.
2. Roof-mounted equipment is not permitted.
3. Front entry door shall have a raised panel design.
4. Garage door shall have a raised panel.
5. Siding shall be wood lap.
6. All roofs shall have a 5:12 pitch
7. Provide a wall sconce on each side of garage door.
8. Front yard landscaping and irrigation shall be provided as indicated on drawings.
9. All windows visible from the street shall be gridded, have decorative trim and sills.
10. All other notes and drawings on the final plans as submitted by the applicant are deemed conditions of approval. Any changes to the final set of plans stamped by Design Review staff shall be subject to review and approval prior to any changes.
