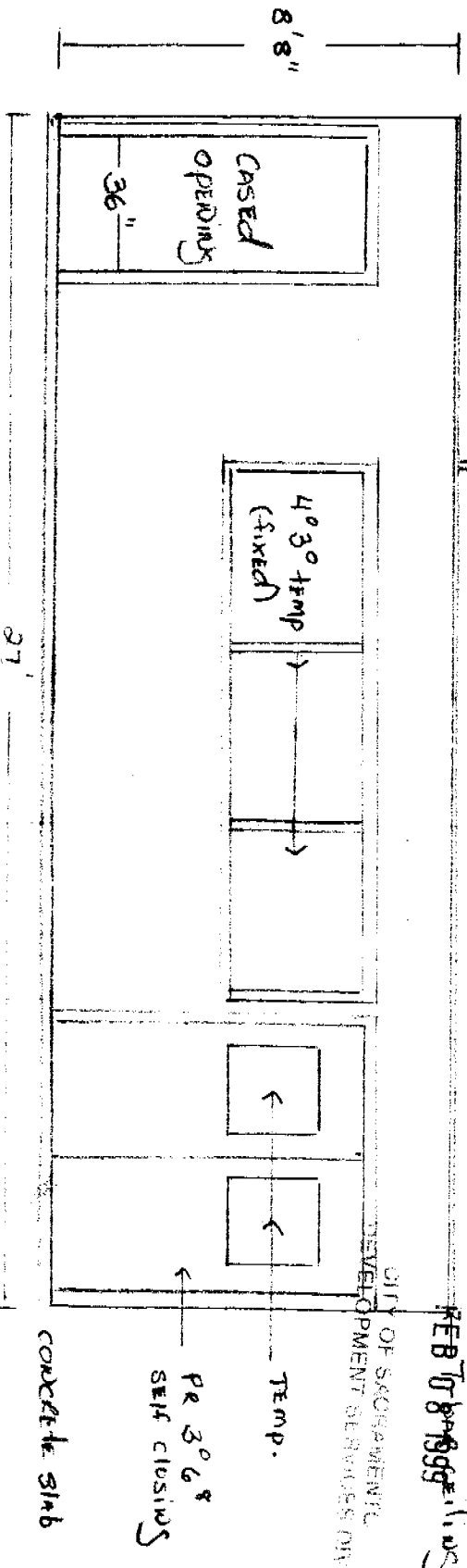

BRACE WALL TO REEF FRAMES ABOUT (TYP)

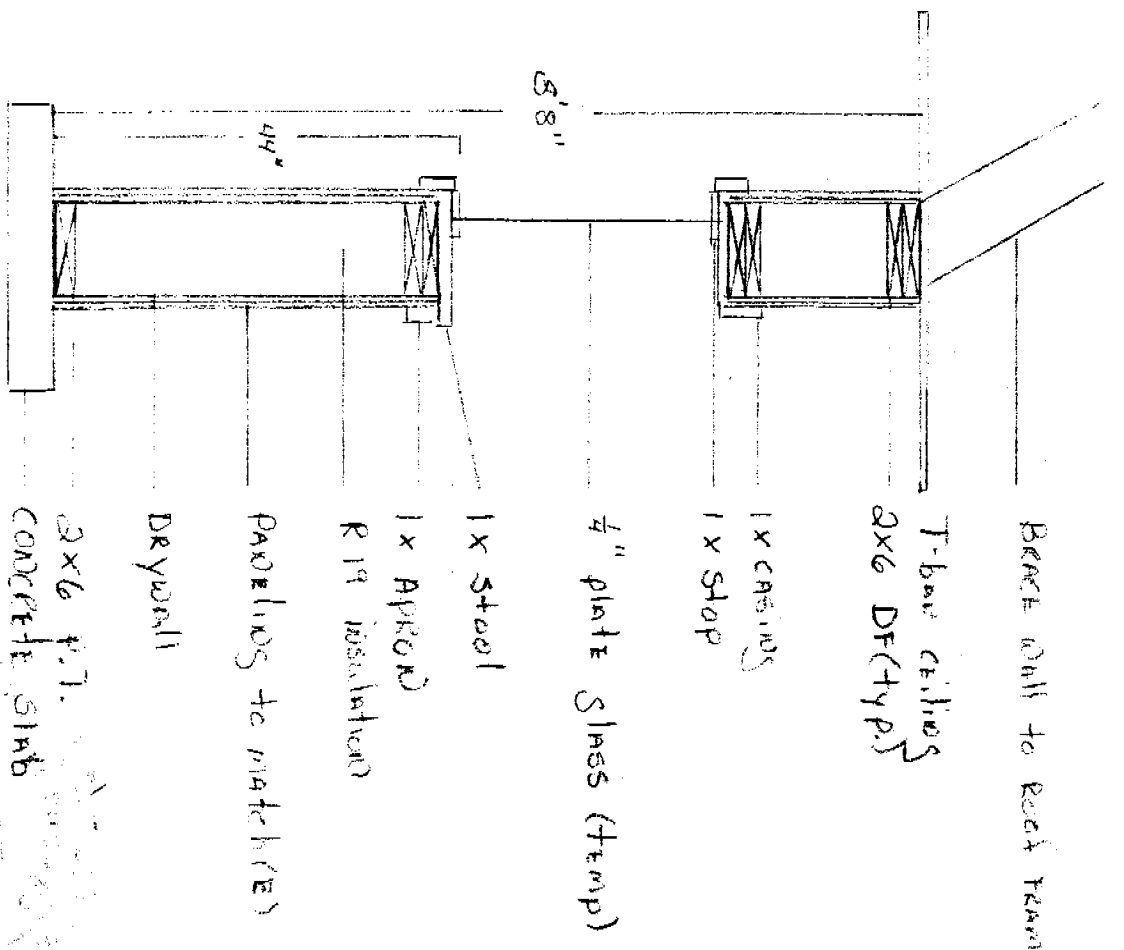

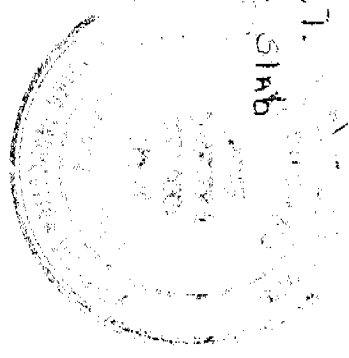
