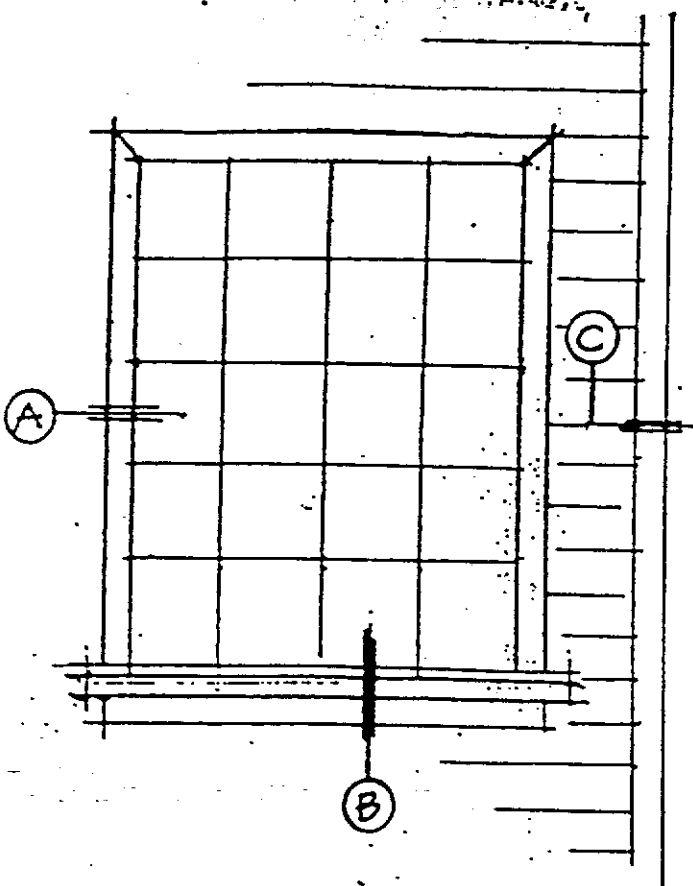

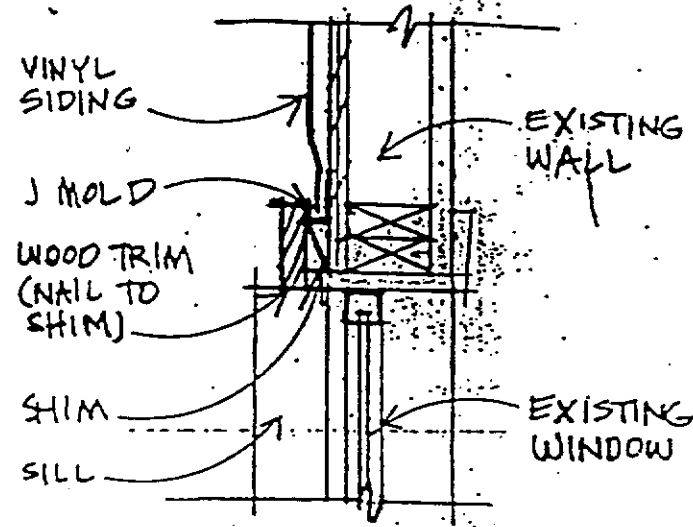

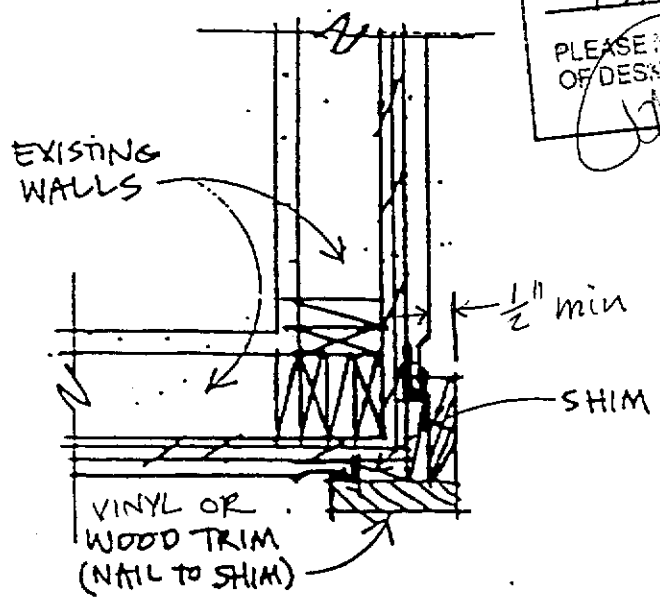


WINDOW ELEVATION

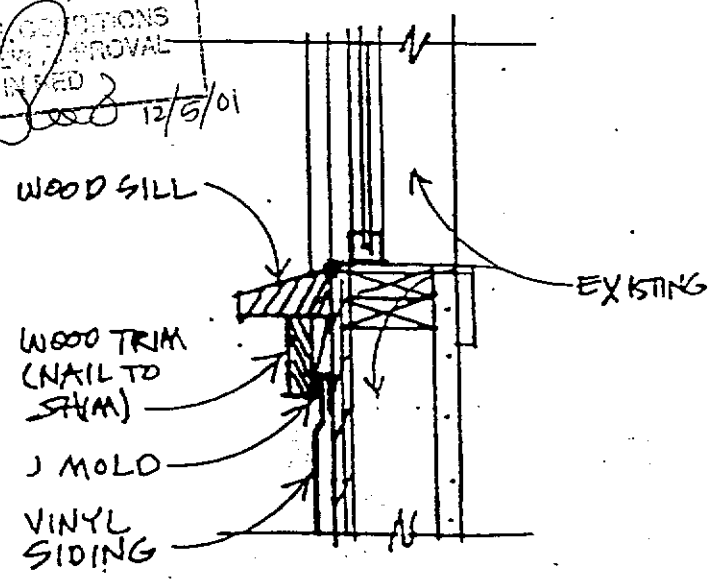


(A) JAMB
