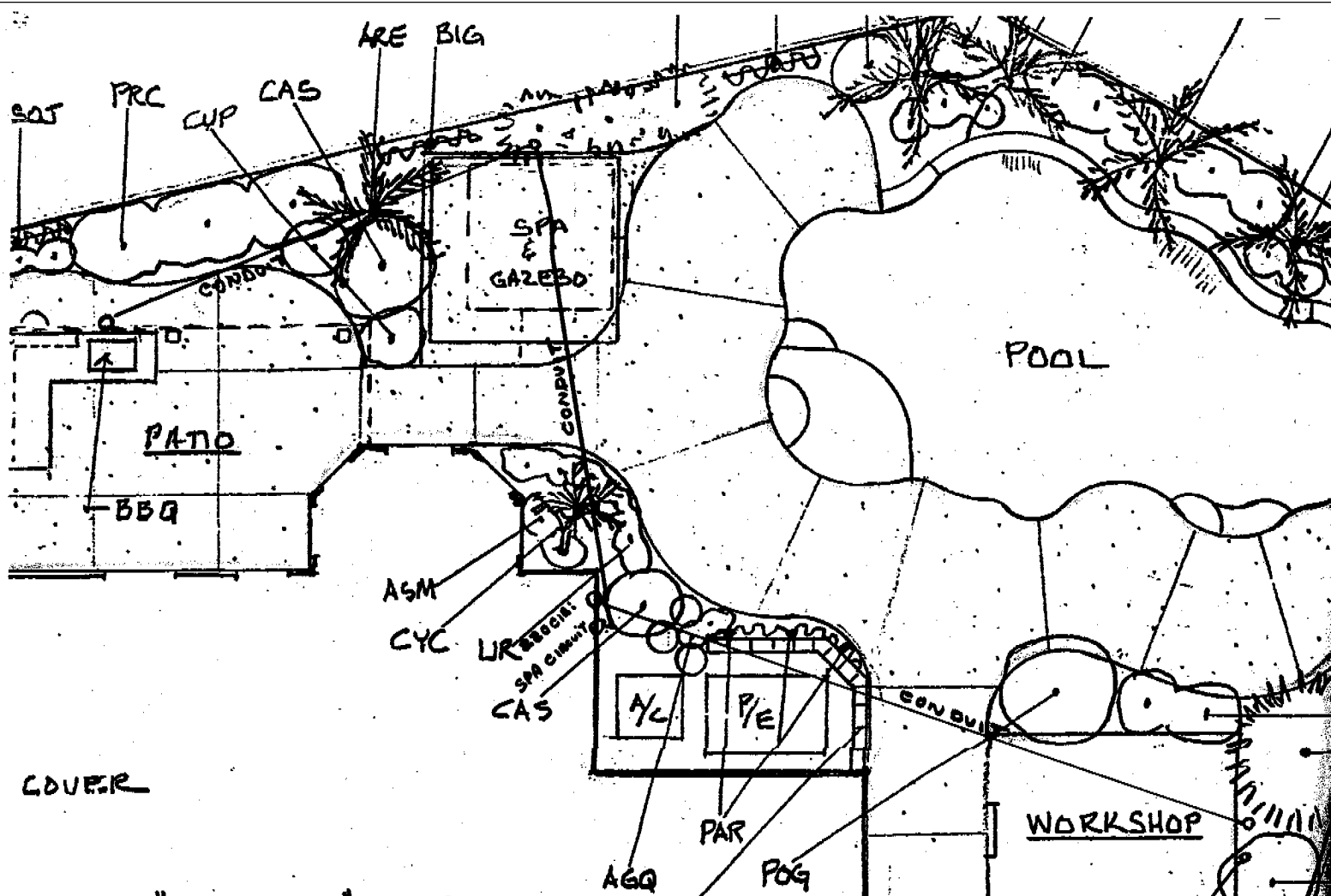

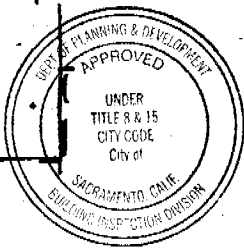
"SPLIT FACE"-TAN CINDER BLOCK WALL 5' HIGH

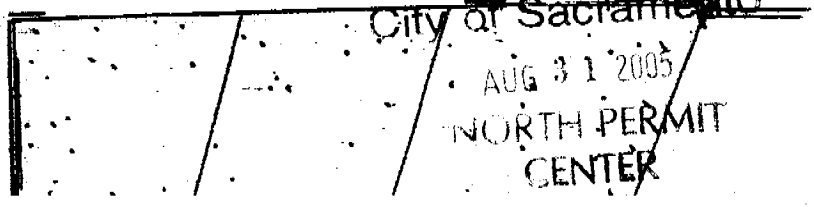
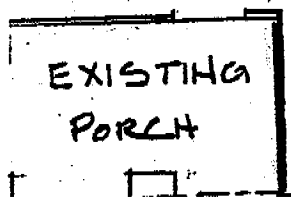
