
Mr. Tugaef:

This purpose of this letter is to state the following:

Tim asked for an alternate sill anchorage for the type F shearwalls at the front of the D units. The original call-out is for 3x4 sill plates with 3/8" x 6" lags @ 6" anchorage. If the 3x4 sill already is in place, Option A of the attached detail may be used using 20d nails @ 4" for the anchorage. If only a 2x4 sill plate exists, Option B must be used. These details are only valid at the Type F exterior shearwalls of unit D.
