The attached report recommends that the City Council, by resolution, authorize the City Manager to execute an Automatic Aid Agreement with the American River Fire Protection District.


RECOMMENDATION

Subject: Automatic Aid Agreement with American River Fire
Protection District

SUMMARY

This report recommends that the City Council, by resolution, authorize the City Manager to execute an Automatic Aid Agreement with the American River Fire Protection District.

RECOMMENDATION

On April 1, 1990, the American River Fire Protection District will consolidate with the Rio Linda-Elverta Fire Protection District. The Rio Linda-Elverta Fire Protection District is located to the north of the Sacramento City limits, east of the Natomas Fire Protection District (City contract area), west of Watt Avenue and south of the Sutter/Placer County line. This is a large area (24.5 square miles) that will be protected by two fire stations. Each station will have three employees assigned to an Engine Company.

The American River Fire Protection District has requested that the Sacramento Fire Department enter into an Automatic Aid Agreement to help protect the southern portion of their jurisdiction. This area is adjacent to the city limits (Ascot Avenue). This agreement will also help the Sacramento Fire Department service portions of our north boundary along Ascot Avenue.

FINANCIAL DATA

There will be no financial impact on the City of Sacramento.

POLICY CONSIDERATIONS

At the present time the Sacramento Fire Department has Automatic Aid Agreements with all the surrounding fire agencies. It has been the City of Sacramento's policy to participate in these agreements.

MBE/WBE EFFORTS

Not applicable.

RECOMMENDATION

It is recommended that the City Council, by resolution, authorize the City Manager to execute an agreement between the City of Sacramento and the American River Fire Protection District for an Automatic Aid Agreement for the southern portion of the old Rio Linda-Elverta Fire Protection District.

1. The City Manager is hereby authorized to execute an agreement with the American River Fire Protection District for Automatic Aid with the Sacramento City Fire Department.

**AGREEMENT FOR AUTOMATIC AID
IN FIRE PROTECTION**

This agreement entered into this 13th day of April, 1990, by and between the CITY OF SACRAMENTO (hereinafter referred to as "City") and the AMERICAN RIVER FIRE PROTECTION DISTRICT (hereinafter referred to as "District"):

WITNESSETH:

WHEREAS it is the desire of both parties hereto that an agreement be executed to provide the benefits of automatic aid in firefighting in the protection of life and property.

NOW, THEREFORE, for and in consideration of the mutual covenants herein contained, it is agreed as follows:

(1) On request to the dispatcher of the AMERICAN RIVER FIRE PROTECTION DISTRICT one pumper and a minimum of three men of the AMERICAN RIVER FIRE PROTECTION DISTRICT will be dispatched to any point within automatic aid response area as designated on the attached map dated April 13, 1990. In the event equipment and manpower are not available from the first in station, Sacramento will be notified.

(2) On request to the dispatcher of the SACRAMENTO FIRE DEPARTMENT, one pumper and a minimum of three men of the SACRAMENTO FIRE DEPARTMENT will be dispatched to any point within automatic aid response area as designated on the attached map dated April 13, 1990. In the event equipment and manpower are not available from the first in station, AMERICAN RIVER FIRE PROTECTION DISTRICT will be notified.

(3) Specific methods of operation. Methods of operation including response, are more specifically set forth on Exhibit A attached hereto and incorporated herein by reference. Any discrepancy between paragraphs 1 and/or 2 and the provisions of Exhibit A shall be resolved in favor of said exhibit.

(4) Any dispatch of equipment and personnel pursuant to this agreement is subject to the following conditions:

(a) The responding organization shall report to the officer in charge of the requesting organization at the location to which the equipment is dispatched and shall be subject to the orders of that official.

(b) A responding organization shall be released by the requesting organization when the services of the responding organization are no longer required or when the responding organization is needed within the area for which it normally provides fire protection.

(5) No party shall be reimbursed by any other party for any costs incurred pursuant to this agreement.

(6) This agreement shall continue in effect until terminated by joint action or both parties hereto or by either party by providing three days prior written notice of such termination to the other party.

(7) All equipment used by the AMERICAN RIVER FIRE PROTECTION DISTRICT in carrying out this agreement will, at the time of action hereunder, be owned by it; and all personnel acting for the AMERICAN RIVER FIRE PROTECTION DISTRICT will, at the time of such action, be an employee or volunteer member of the AMERICAN RIVER FIRE PROTECTION DISTRICT.

(8) All equipment used by the CITY OF SACRAMENTO FIRE DEPARTMENT in carrying out this agreement will, at the time of action hereunder, be owned by it; and all personnel acting for the CITY OF SACRAMENTO FIRE DEPARTMENT will, at the time of such action be an employee or a volunteer member of the CITY OF SACRAMENTO FIRE DEPARTMENT.

(9) Notwithstanding any other provision herein, this agreement shall not be construed in any manner so as to abridge the rights, privileges or immunities afforded public entities under state law as set forth in Government Code Section 810, et seq.



AUTOMATIC AID

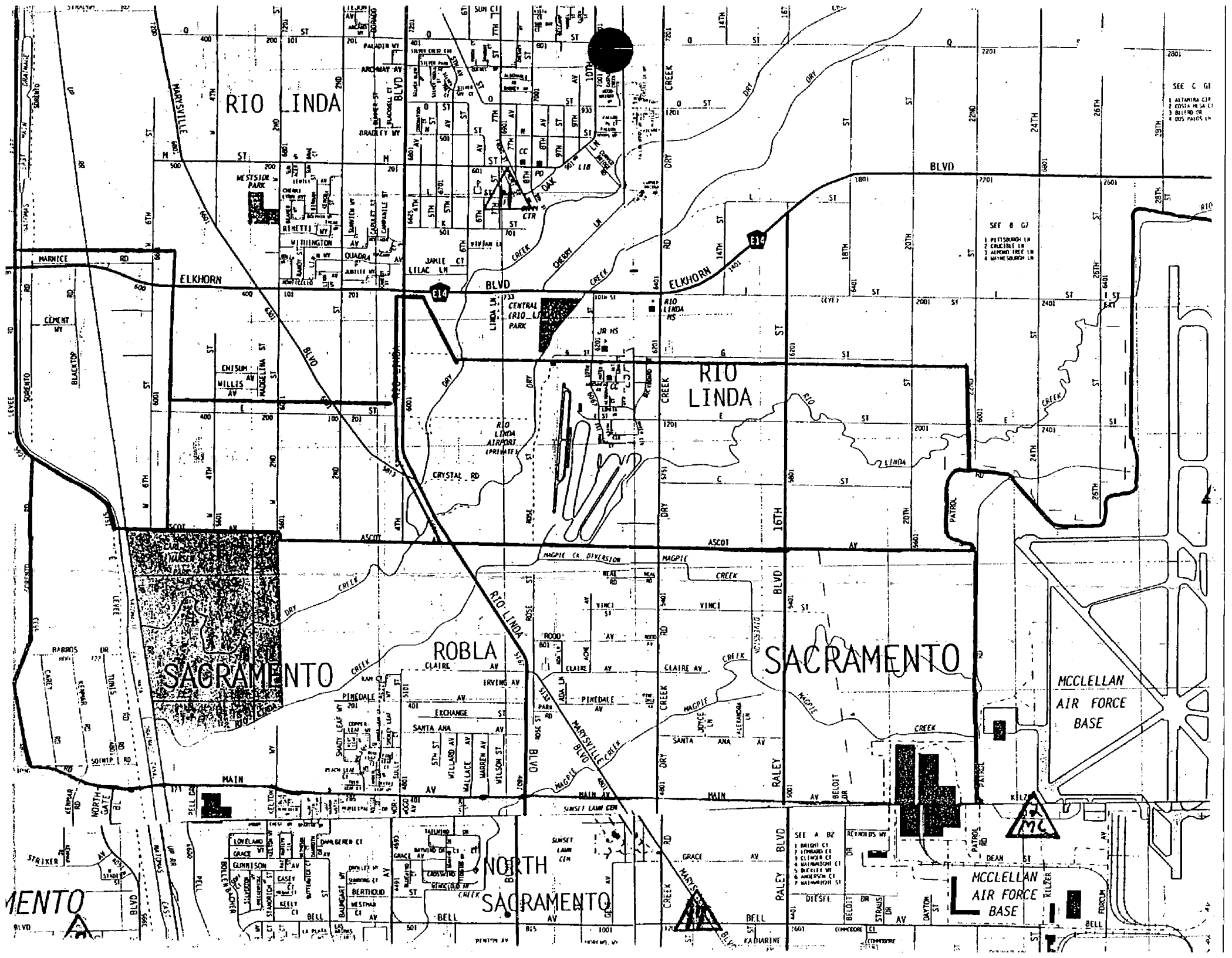
SACRAMENTO AND AMERICAN RIVER FIRE PROTECTION DISTRICT

The intent of the April 6, 1990 agreement between the CITY OF SACRAMENTO and the AMERICAN RIVER FIRE PROTECTION DISTRICT is to have an initial response of one Engine to designated areas. This may be a first responder due to close proximity of the station or an Engine to be part of a full assignment. The response will be for all incidents.

METHODS OF OPERATION WILL BE AS FOLLOWS:

1. Responsible agency will also respond and relieve first company when practical and take care of report information.
2. First in company to notify second agency to reduce response to Code 2 as soon as situation is under control.
3. Radio frequency to be used will be that of the responsible agency.
4. Meetings will be held between companies of each agency to review methods of operation and response areas, and answer any questions as to methods of operating.
