**SUBJECT:** Rio Linda Boulevard from Silvano Street to Arcade Boulevard (PN:TB91) -  
Fund Transfer and Contract Award

**SUMMARY**

This project has been advertised for bid. Bids have been received and additional funding of \$125,000 is needed for bid award. Fund transfer and contract award is recommended. The Budget and Finance Committee reviewed this item at its meeting of April 5, 1988.

**BACKGROUND**

This project includes widening Rio Linda Boulevard to four lanes with parking, curb, gutter, sidewalk and street lighting from Silvano Street south to Arcade Boulevard. This section of roadway will complete the widening of Rio Linda Boulevard from Highway I-80 south to El Camino Avenue. The project includes necessary drainage, sewerage and water facilities and the reconstruction of the bridge over Arcade Creek.

This project required acquisition of a portion of 36 parcels including the displacement of six dwellings. Individuals have been relocated as required for approval by the Federal Highway Administration (FHWA).

According to the requirements for a Finding of No Significant Impact, a hearing was held June 23, 1983. City Council approved a Negative Declaration for this project on May 1, 1984.

Plans and specifications were completed, right-of-way obtained and certified and permission to advertise was granted from Caltrans and FHWA on December 22, 1987.

The project was approved for advertizing by City Council and bids were received on March 1, 1988. The bids received were:

Grade-Way Construction	\$1,899,476

The engineer's estimate for the subject project was \$2,123,464. The low bid of \$1,899,476 is 10.5% below the estimate.

In order to expedite the start of construction the staff recommendation for the City Council to award the construction contract is made in anticipation of receiving contract award authorization from Caltrans by April 5. If the formal authorization to award is not received by April 5, staff will recommend continuance of this item.

#### FINANCIAL

The estimated total project cost, including engineering design administration, right-of-way acquisition, construction, construction contingencies, construction inspection and administration is \$3,116,000. Federal Aid Urban (FAU) funds will reimburse the City for 86% of construction costs, right-of-way and project specific City labor costs. The estimated FAU contribution for this project is \$2,477,000; the estimated City contribution is \$639,000. The Local Agency/State agreement required to obtain FAU funds was approved by the City Council on March 15, 1988.

City funds currently budgeted for this project are as follows:

Additional funds in the amount of \$125,000 are required for contract award. This deficit is due to an increase in project scope and construction costs since the project was originally budgeted in fiscal year 1978/79. Also City indirect costs are not reimburseable by FAU funding. It is proposed that the required additional funds be obtained as follows:

Defund and transfer from Howe/La Riviera (PN:TA56) - Construction has been completed and this project was accepted by the City Council on December 8, 1987. A surplus of approximately \$25,000 is available for use on the Rio Linda Boulevard project.
