### SUMMARY

It is requested that Resolution No. 85-064, relating to Conflict of Interest, be amended to reflect the transfer of certain engineer, architect, and construction inspector positions from the Department of Public Works to the Department of General Services and to establish the categories of the Conflict of Interest Code under which the positions will be required to file.

### BACKGROUND

On January 29, 1985, City Council approved an amended Conflict of Interest Code for the Department of Public Works. On the same date, Council approved the transfer of certain engineer, architect, and construction inspector positions from the Department of Public Works to the Department of General Services. Since these classifications are new to the Department of General Services, it is necessary to establish Conflict of Interest Code categories under which these positions will be required to file.

### RECOMMENDATION

It is recommended that the City Council adopt the attached resolution amending Resolution 85-064 to reflect the changes as noted above.
