IV: COMMITTEE REPORTS (5 MINUTES): None, Director Walker made announcement that APP Specialist Ann Mottola had resigned her position to accept a position with the City of Folsom. Mottola addressed Commission and thanked staff and Commission for her past three years.

II. ACTION ITEMS:

A. APPROVAL OF DONATION OF JIAN WANG PAINTING (BLOOM): Bloom

Bloom said that resume of Wang was in report. Donation is original oil painting on canvas valued at \$42,000 by Art Expressions Gallery. Art will be installed in Convention Center at their request. Installation expenses estimated at \$400 or less.

B. APPROVAL OF DONATION OF HORST LIESSL DRAWING (BLOOM)::

Bloom said that Horst Liessl had passed away and Maurice Read and Julia Liessl have donated this work along with other donors. Bloom introduced Maurice Read. Read stated Liessl had been a long standing Artistic presence in Sacramento Area for many years and provided surrealistic work. Bloom stated City Hall is being considered for its installation.

A. SMAC Budget (Mackay): Mackay passed out budget report to SMAC Commissioners. Walker stated that the Poet Laureate program should also be identified for FY06 for \$20K. Mackay stated that the budgets were essentially the same as per the May briefing. Giger asked if the APP budget was less than last year and Mackay stated the general backlog was down some, with a shift from City Projects to County Projects.
