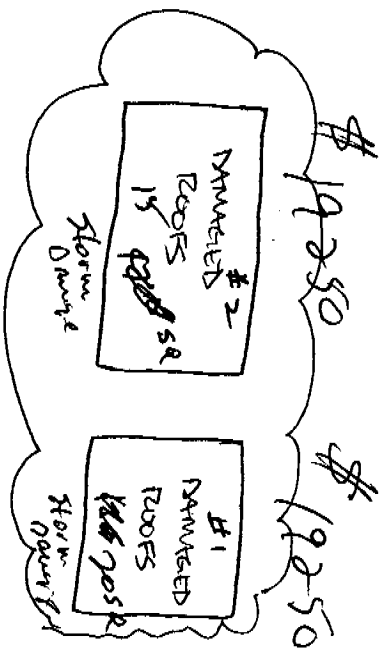
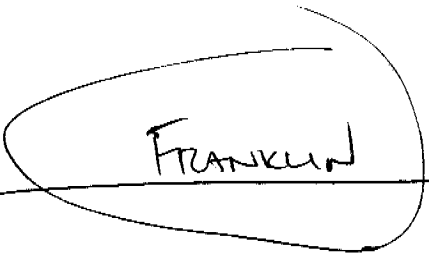
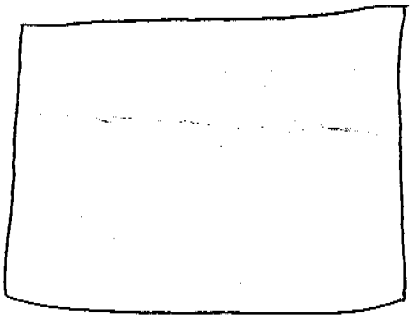
SITE PLAN
