PORT HAS SECOND BEST YEAR

The results of 1981 were the second best year in the history of the Port. Cargo movements were at a slightly reduced level from the record set in 1980. 2,960,910 tons of cargo moved in 1981, slightly down from the all time record 3,257,303 that was set last year. However, when compared to the previous record year in 1979 at 2,176,569, this year was still a very good year. Activity during the fourth quarter was also down a little from last year's level. The world-wide economy recession has slowed cargo movements in the past several months.

Considerable construction has been progressing during the year. The Port is nearing the completion of a warehouse expansion to create an additional 125,000 tons of covered storage space. A new conveyor and ship loading system is also under construction. Both projects have been hampered slightly this year due to the electrician's strike in Northern California. Final completion is scheduled for early spring.
