

On detail C/S4.1, the framing contractor has requested placing the plywood shear panel on the outside face of the stud wall (between the studs of the party wall). The shear transfer between the plywood shear panel along the side of the prefabricated wood trusses to the top plate of the shear wall shall provided with placement of A35 clip @ 12"oc from the bottom chord of the prefabricated wood truss to the 2x12 top plate. The remaining information provided on detail C/S4.1 shall apply.
