


Dear Building Department.

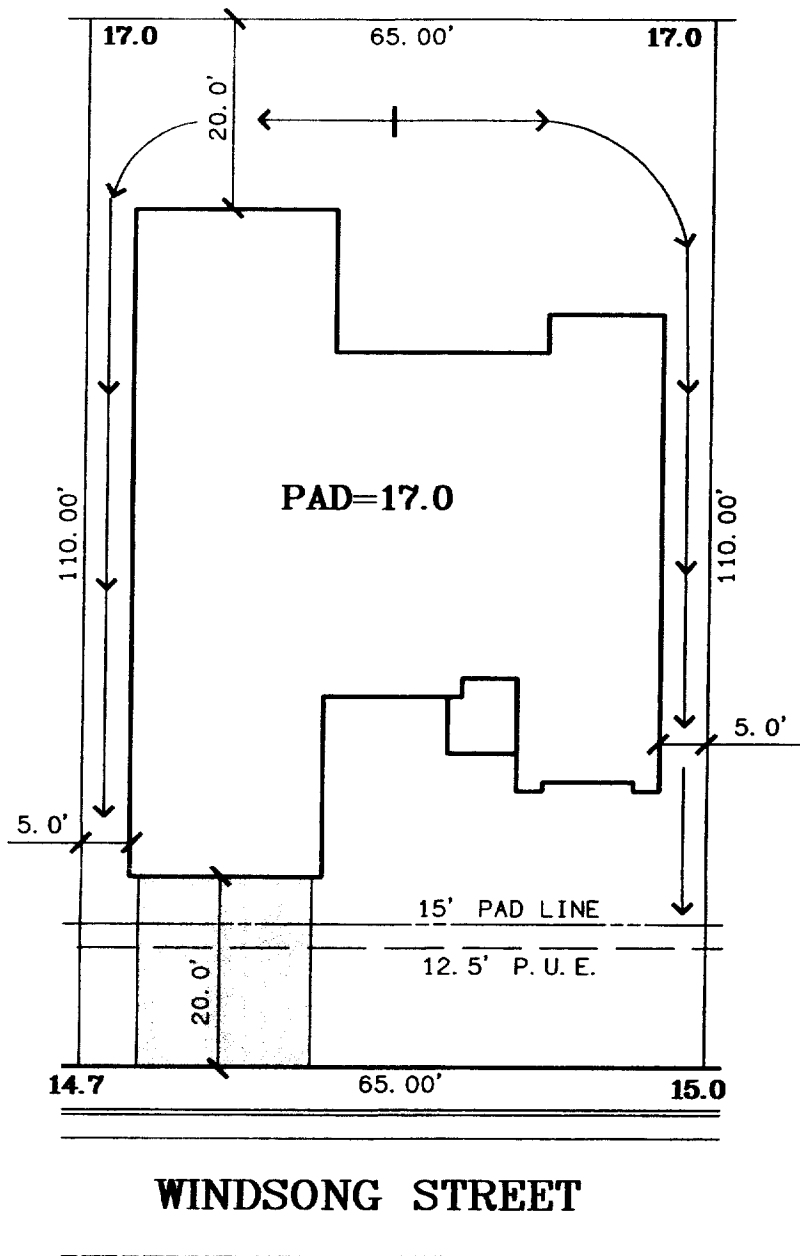

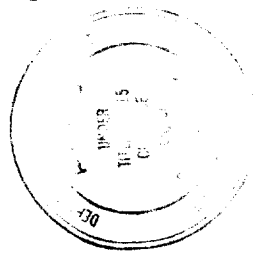
