



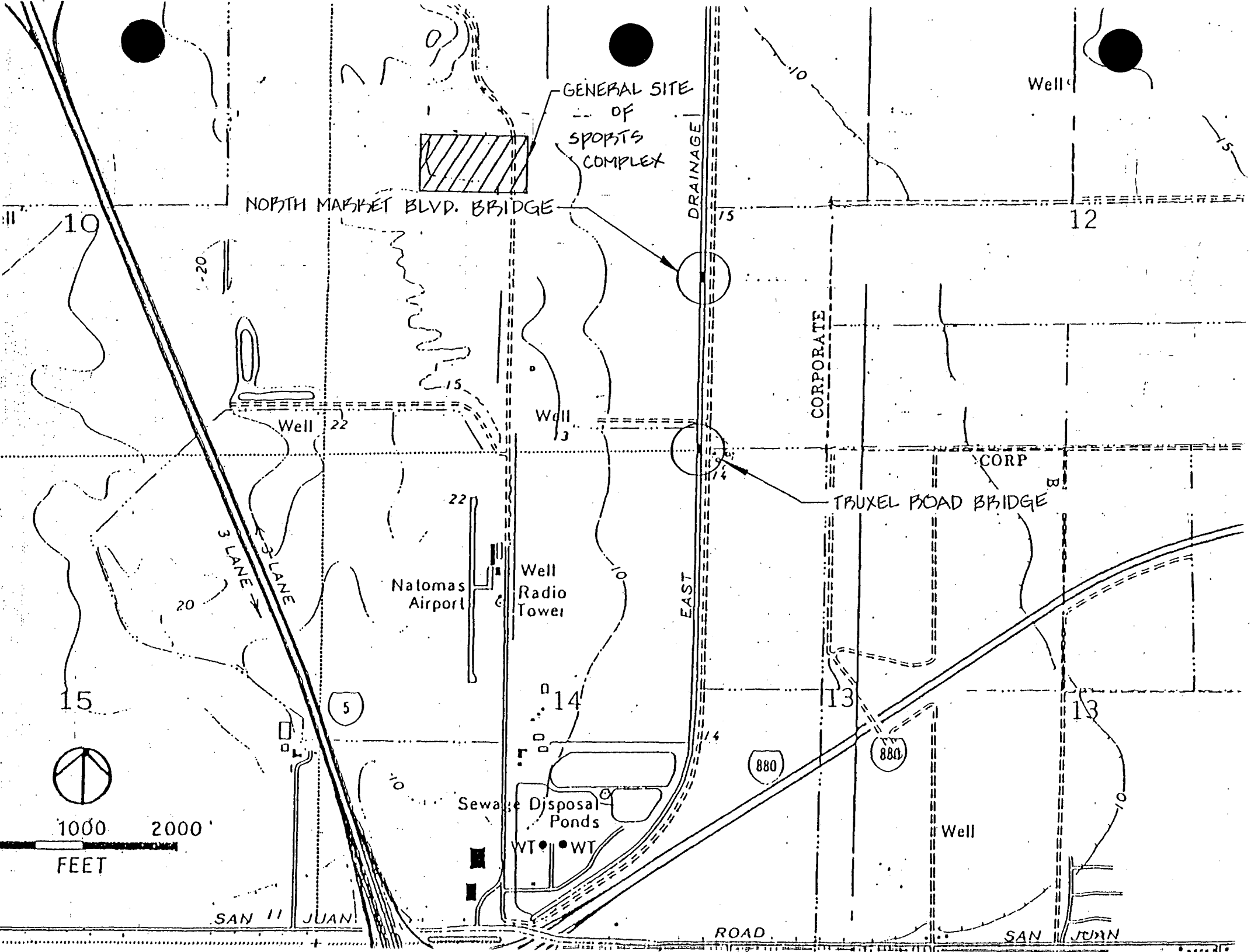

SUBJECT: North Market Boulevard and Truxel Road Bridges Over the East Canal  
(JN:9890/9891) - Consultant Services Agreement - North Natomas

SUMMARY

It is requested that a Consultant Services Agreement be entered into with Nolte and Associates for the North Market Boulevard and Truxel Road Bridge projects. A project budget of \$89,000 is also recommended. This item was considered by the Budget and Finance Committee at their meeting of June 16, 1987.

BACKGROUND

The North Market Boulevard and Truxel Road Bridges will provide access to the sports complex and are integral to the North Natomas Community Plan circulation element (see the attached map).

Presented for approval is a Consultant Services Agreement in the amount of \$74,528 with Nolte and Associates to provide construction inspection, construction surveying, and materials and soils testing during construction of the North Market Boulevard and Truxel Road Bridges over the East Canal in North Natomas.

FINANCIAL

The proposed project budget is \$89,000. The Developer has already made payments of \$18,000 and \$71,000, totalling \$89,000, to the City to fund the project. There is no net cost to the City incurred by this agreement.
