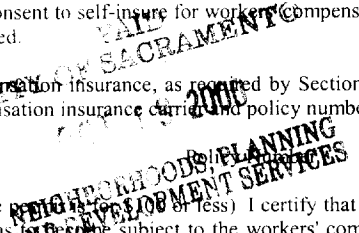

STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Roofing shall be 25-year laminated dimensional composition shingle.
2. Existing windows, trims and sills shall remain. Repair as necessary to match existing.
3. Replace existing wood shake shingles as necessary to match existing.
4. Patch and repair existing stucco siding as necessary to match existing color and texture.
5. Repair roof eaves to match existing
6. Gutters and downspouts shall be provided.
7. Paint exterior.
8. No new roof-mounted mechanical equipment is allowed.
9. Remove and clear site of all debris.
10. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
