SUBJECT: Authorization to Submit Grant Application to the California  
State Department of Education

SUMMARY

This report provides information regarding extended day care services and facilities. Further, this report recommends authorization for the City Manager to submit a grant application to the California State Department of Education - Child Development Division on behalf of the Recreation Division of the Department of Parks and Community Services.

BACKGROUND INFORMATION

During the 1985 session, the California State Legislature enacted the Community Care Service Act, the "Latchkey" bill. This bill provided funding for before and after-school care for school age children under which the City of Sacramento received funding for its extended day program.

The Recreation Division, in partnership with the Sacramento Unified School District, currently operates twelve elementary school child care facilities. The City is the lead agency and operates and administers the entire program. The District provides the sites and the necessary coordination to integrate the program with school operations.

With increasing school enrollment, the space available for child care is becoming increasingly limited. This reduces the Recreation Division's capabilities to provide extended day services.

The State's SB303, Capital Outlay Allocation, provides relocatable facilities from the State's School Age Community Child Care Services. Under this program, the Recreation Division is applying for eighteen relocatable facilities which will be placed on Sacramento Unified School District sites.

The total value of each of these relocatable facilities is approximately \$130,000 and will cover costs of the facility, installation and all utility hook-ups. The Recreation Division will lease any granted facilities for \$1 annually, per facility and will be responsible for maintenance of the facilities.

Location of the facilities will be determined and co-ordinated by the Sacramento Unified School District and the Recreation Division. The District will be responsible for utilities following installation of the facilities.

FINANCIAL DATA

Total value of the eighteen relocatable facilities for the Recreation Division's extended day care program, at \$130,000 per facility, is estimated at \$2,340,000.


Cost of leasing granted facilities is \$1 annually per facility. This cost will be covered by funds from the Latchkey Special Revenue Account.

No City funds are requested.


RECOMMENDATION

It is recommended that the Budget and Finance Committee review this report and refer it to the City Council for action. Further, it is recommended that the City Council, by resolution, authorize the City Manager to submit, on behalf of the Department of Parks and Community Services, Recreation Division, a grant application for relocatable facilities to the California State Department of Education - Child Development Division.

# RESOLUTION NO.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION AUTHORIZING THE FILING OF APPLICATIONS WITH THE STATE DEPARTMENT OF EDUCATION AND THE STATE ALLOCATION BOARD, APPOINTING AN AUTHORIZED AGENT AND A CALIFORNIA ENVIRONMENTAL QUALITY ACT OFFICER TO ACT ON BEHALF OF THE AGENCY IN ALL MATTERS RELATING TO THE CHILD CARE AND DEVELOPMENT PROGRAM.

WHEREAS, The City of Sacramento, hereinafter referred to as the "Agency", is applying to the State Department of Education and the State Allocation Board for the lease of relocatable child care building(s) and/or a loan or grant for the renovation and repair of existing child care facilities pursuant to Chapter 2, Part 6 of the Education Code and for such purposes, is authorizing certain required actions in connection with said application(s);

NOW, THEREFORE, BE IT RESOLVED BY the City of Sacramento as follows:

1. That the City Manager is hereby designated as Authorized Agent and California Environmental Quality Act Officer of the Agency and is hereby authorized and directed to file, on behalf of the Agency such applications(s) with the State Department of Education and the State Allocation Board under Chapter 2, Part 6 of the Education Code as the Chairperson or President and Clerk or Secretary of the Governing body may certify as provided herein.

I, Lorraine Magana, Clerk of the City of Sacramento, State of California, do hereby certify the foregoing to be a true and correct copy of a resolution adopted by the Governing Body of the aforesaid Agency at a regular meeting held on the 7th day of April 1987, as the same appears on record in my office.
