SUBJECT: REQUEST FOR RESOLUTION AUTHORIZING STATE LIBRARY
SCHOLARSHIP FOR MR. CONRAD YAMAMOTO

SUMMARY

The City-County Librarian requests authorization for an increase in appropriations for the Library Department in the amount of \$3,000. This amount was awarded Conrad Yamamoto on his application to the Minority Recruitment Program of the California State Library.

BACKGROUND INFORMATION

In January of this year, the California State Library invited applications for the Minority Recruitment funds from Title I of the Library Services and Construction Act. The purpose of this program is to increase the number of minority librarians and improve library service to minority groups in California. The City-County Librarian was invited to nominate a candidate for scholarships to be awarded in April 1980. The total of \$40,000 included scholarships up to \$3,500 for Masters of Library Science. Conrad Yamamoto was nominated for consideration as recipient of a scholarship; his application was submitted to the State Library and in April 1980, notification was made of the award of the scholarship to Mr. Yamamoto.

FINANCIAL DATA

The State Library has awarded a \$3,000 scholarship to Mr. Yamamoto to be administered by the City of Sacramento, through the City Library. The scholarship is funded totally by the Minority Recruitment Scholarship award.

RECOMMENDATION

It is therefore recommended that the attached resolution authorizing an increase in library appropriations to accommodate the expenditure of LSCA scholarship funds for Mr. Conrad Yamamoto be approved.


