

SUMMARY

This report requests adoption of the attached resolution which declares the official results of the March 2, 1999 Special Municipal Election, as certified by the County Registrar of Voters.

BACKGROUND INFORMATION

On Tuesday, March 2, 1999, the City of Sacramento held a Special Municipal Election for the purposes of electing a Councilmember to fill a vacancy in Council District 6.

On November 10, 1998, the City Council adopted resolution number 98-551 authorizing the County Registrar of Voters Office to canvass the returns of the election. The results have been certified by the \$ \$ 5 **

County, and are contained in the attached Certificates of Fact. Pursuant to the results contained in the Certificates of Fact, the number and percentage of votes received by Dave Jones is sufficient to declare him elected.

FINANCIAL CONSIDERATIONS

The County has determined that \$90,027.00 will cover the costs involved in conducting this election.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SACRAMENTO, CALIFORNIA, RECITING THE FACTS OF THE SPECIAL DISTRICT SIX MUNICIPAL ELECTION HELD ON MARCH 2, 1999, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a Special District 6 Municipal Election was held and conducted in the City of Sacramento, California, on Tuesday, March 2, 1999, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California; and

WHEREAS, pursuant to Resolution Number 98-551 adopted on November 10, 1998, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SACRAMENTO, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the number of votes cast in the City, including absentee ballots, was 4,786.


SECTION 2. That the names of persons voted for at the election and the results of the votes cast are as follows:

The City Council does declare and determine that Dave Jones was elected as Councilmember to District #6 for the remaining portion of the term, from March 9, 1999 through November 28, 2000.

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for office of District #6 Councilmember, are listed in Exhibit "B" attached.

SECTION 4. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) the whole number of votes cast in the City; (2) the names of the persons voted for; (3) for what office each person voted for; (4) the number of votes given at each precinct to each person; and, (5) the total number of votes given to each person.

SECTION 5. That the City Clerk shall on March 9, 1999, and pursuant to California Elections Code Sections 10265, make and deliver to the person so elected a Certificate of Election signed by the City Clerk and authenticated, that the City Clerk did also administer to the person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. The person so elected shall then be inducted into the respective office to which he has been elected.

SECTION 6. That the Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.




