MINUTES:

Gary Szydelko, Senior Architect, made a presentation on space needs for the public safety facilities (Police and Fire). He stated that the location being recommended for these facilities is adjacent to City Hall in order to centralize administrative functions. Also being recommended was the construction of four patrol substations in the south, east, north, and central areas in order to relieve overcrowding at current police facilities and decentralize patrol.

Mr. Walter Rohrer and Mr. Dan Smith, Space Needs Consultants, answered questions the Committee had on land use, cost, public lease office option, substation area priorities, etc.

Frank Migartegui, Director of General Services, stated that the space consultants were brought in to assess the City's space needs and that the financing program has not been

MINUTES:

Reg Young, Deputy Director, stated that after examining the revised figures from the County of Sacramento regarding the issue of joint kenneling of City/County animals, staff is recommending that City staff proceed with plans to build a City owned animal control facility.

Committee member Kastanis asked whether negotiations had been reopened with the Board of Supervisors as had been requested at the January 6, 1987 Committee meeting.

Solon Wisham, Jr., Assistant City Manager, replied that staff had met with County officials including Board Chairman Toby Johnson and it had been made clear at that meeting that the County was not in favor of a joint effort regarding kenneling. Since then, the City Manager's office and the Mayor's office have received correspondence from the County requesting further discussions on the joint kenneling issue.


Chair Serna stated that City staff needs to proceed with plans to build a city-owned animal control facility and stated that if further discussions were in order city staff could do so at a later date.
