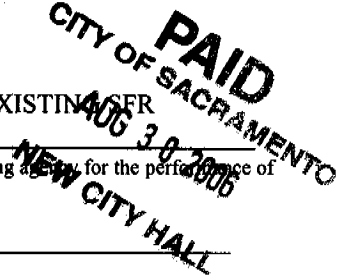

CONDITIONS AND COMMENTS: APPLICANT IS PROPOSING A 335.75 SQ.FT PATIO (LATTICE) COVER TO EXISTING TWO-STORY SFR. ADDITION WILL TAKE PLACE IN REAR AND SIDE YARD SETBACK OF SFR. THE PATIO COVER WILL NOT BE ENCLOSED. LOT AREA = 6534 (METROSCAN) EXISTING FOOTPRINT = 1846.25. PROPOSED FOOTPRINT = 2182/6534 = 33.4% LOT COVERAGE, WHICH IS CONSISTENT WITH ZONING CODE REQUIREMENTS. SIDE YARD SETBACK = 12.5 FT. SITE PLAN IS SHOWING 12 FT, HOWEVER, A COVERED PORCH NOT EXCEEDING A HEIGHT OF TEN FEET TO THE PLATE LINE MAY EXTEND A MAXIMUM OF 25% INTO A REQUIRED STREET SIDE YARD SETBACK AREA. ALL SETBACK AND LOT COVERAGE REQUIREMENTS ARE MET. NO PLANNING ENTITLEMENTS APPARENT AT THIS TIME. SITE PLAN MEASUREMENTS ARE SLIGHTLY OFF, HOWEVER ALL SETBACK AND LOT COVERAGE REQUIREMENTS ARE MET.
