SUBJECT: Agreements with the County of Sacramento for the Sacramento Metropolitan Arts Commission and Museum and History Commission

SUMMARY

This report requests authorization to execute separate agreements with the County of Sacramento for their FY 1986-87 support of the Sacramento Metropolitan Arts Commission and Sacramento Museum and History Commission.

BACKGROUND INFORMATION

The Sacramento Metropolitan Arts Commission and Sacramento Museum and History Commission function as a joint City-County effort. Each year, the City and County approve these budgets appropriating funds in the City budget, 50% of which are to be reimbursed by the County of Sacramento. An agreement between the City and County for each Commission is necessary to facilitate this funding support.

The approved City 1986-87 fiscal year budget included County support of \$76,668 for the Metropolitan Arts Commission and \$153,991 for the Museum and History Commission. The agreements reflect these amounts.
