SUMMARY

This report recommends approval of an extension for one Limited-term Staff Aide position beginning February 1, 1987 until the end of 1986/87 fiscal year to meet an immediate need in the Library Department until an appropriate class specification can be developed.

BACKGROUND INFORMATION

A classification study is in progress for all library positions. At the conclusion of the study, necessary revisions will be made to Library class specifications.

It is important that the Library have this position extended at this time to continue to oversee the 1986/87 budget and prepare information for the 1987/88 budget for both City and County systems.

There are also ongoing fiscal activities requiring attention. The Library has no staff to perform these duties at this time in the absence of the vacant Deputy Library Director, Administrative Services.

FINANCIAL IMPACT

Funds are available through the current Library budget. It is a shared cost position. It is recommended that the salary be set at \$18.00 per hour with benefits. The City's portion (44%) would be \$9,240. The County's portion (56%) will be \$11,760. The total funds \$21,000 will come from Line 4258 (Other Professional Services). The funds will be transferred from Line 4258 (Other Professional Services) to Line 4101 (Salary and Wages). Since this is a shared cost position, the County's portion, \$11,760 will be reimbursed in the shared cost budget.
