NORTHERN CALIFORNIA REGIONAL PUBLIC SAFETY TRAINING COLLEGE – JOINT POWERS AUTHORITY, FY2007/08 ANNUAL BUDGET

BACKGROUND

- A. The Northern California Regional Public Safety Training College (NCRPSTC) was established in 2001 at McClellan Business Park as a Joint Powers Authority (JPA). (City Council Resolution 2001-137.)
- B. The NCRPSTC JPA consists of the County of Sacramento, the City of Sacramento, the California Regional Fire and Rescue Training Authority, and the Los Rios Community College District.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Council approves the NCRPSTC – Joint Powers Authority FY 2007/08 Annual Budget totaling \$5,359, 241.
- Section 2. The City Council approves payment to the NCRPSTC JPA for the Sacramento Police Department's use of rental space in the amount of \$237,625.
