BACKGROUND INFORMATION

The Council awarded a contract to Granite Construction Company on June 5th, 1979 for constructing concrete curb, gutter and sidewalks, asphaltic concrete pavement, storm sewers, drainage facilities, sanitary sewers, sewer services, water distribution system complete and street lighting system complete in the above named Assessment District. At the time of signing the contract, the completion date was scheduled for December 17th, 1979. The work has been completed, however, the assessment must be spread.
