Subject: Parking Restrictions on a Portion of V and 8th Streets

Location/Council District: V Street, south side, from 8th to 9th Streets and 8th Street, east side, eighty feet south of V Street (District 4).

Recommendation:

Adopt a Resolution to remove the two-hour parking time limit and prohibit all parking from 6:00 am to 7:30 am on a portion of V and 8th Streets.

Summary:

Two schools will be operating out of the Leeland Stanford Administrative Annex School building at 8th and V Streets beginning in September 2005. The school only has eleven off-street parking spaces. School representatives have requested that the parking adjacent to the school be prohibited in the early morning and unregulated the remainder of the day. This will allow school staff an equal opportunity to compete for the available on-street parking. Installing regulatory parking signs will cost approximately \$500. Funds are available in the Parking Services Division operating budget.

Committee/Commission Action: None.

Background Information:

In September 2005 two schools are scheduled to open in the Leeland Stanford Administrative Annex School building located at 8th and V Streets. There are only eleven off-street parking spaces. The school is in the Southside residential permit parking area and non-resident street parking is limited. School representatives have requested that all street parking adjacent to the school be prohibited from 6:00 am to 7:30 am and unregulated the remainder of the day. Currently, this parking is regulated with a two-hour parking time limit. Unregulated parking in this area typically fills to capacity with commuter parkers early in the morning prior to the hours that school personnel begin work. Prohibiting all parking from

6:00 am to 7:30 am will prohibit early commuter parkers from taking all of the available unregulated street parking and provide school staff equal opportunity to compete for the available street parking.

Financial Considerations:

The cost to replace the existing parking regulatory signs is estimated to be \$500. Funds are available in the Parking Services Division operating budget.

Environmental Considerations:


The Development Services Department, Environmental Services Division has reviewed the recommendation to implement parking restrictions on a portion of V and 8th Streets and has determined that the project is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301 (c) and Class 11, Section 15311 (a) of the CEQA guidelines. Projects exempted under Class 1, Section 15301 (c), consist of the operation, repair or minor alterations of existing highways, streets, sidewalks, gutters, bicycle and pedestrian trails and similar facilities involving negligible or no expansion of use. Projects exempted under Class 11, Section 15311 (a), consist of the construction or replacement of minor structures accessory to existing commercial, industrial or institutional facilities, including but not limited to on-premise signs.

Policy Considerations:

This recommendation is consistent with the City's' strategic plan and the goal of the City Council to promote economic viability.



APPROVING PARKING RESTRICTIONS ON A PORTION OF V STREET INCREASED

BACKGROUND

- A. In September 2005 two schools are scheduled to open in the Leeland Stanford Administrative Annex School at 8th and V Streets.
- B. School representatives have requested that the two-hour parking time limit street parking adjacent to the school be removed and all parking be prohibited from 6:00 am to 7:30 am.
- C. Prohibiting all parking from 6:00 am to 7:30 am will prohibit early morning commuter parkers from taking all of the available unregulated street parking and provide school staff equal opportunity to compete for the available street parking.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

Section 1. Remove the two-hour parking time limit and prohibit all parking from 6:00 am to 7:30 am. On the following streets;

- V Street, south side, from 8th to 9th Streets.
- 8th Street, east side, eighty feet south of V Street.

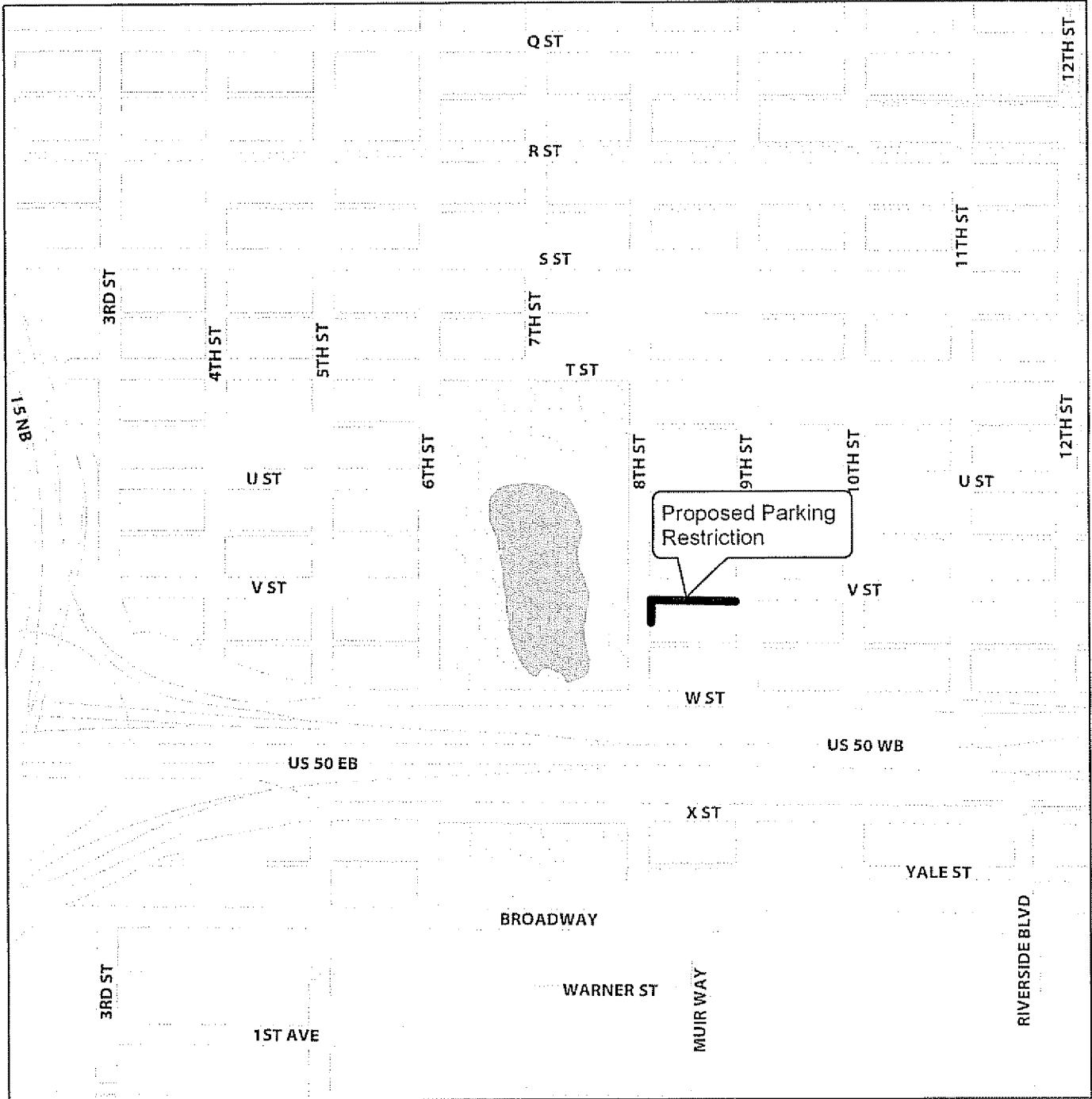
