

RESOLUTION NO. 2009-128

Adopted by the Sacramento City Council

March 3, 2009

APPROVING A PROPOSED INCREASE TO CITY PARKING CITATIONS AS A RESULT OF STATE-MANDATED SURCHARGES

BACKGROUND

- A. In December 1993, the Sacramento County Superior Court transferred the responsibility for processing parking citations to the City. Concurrent with this action, the State mandated a \$5 parking-penalty surcharge pursuant to Government Code section 76000 for all citations issued within the County of Sacramento. This \$5 surcharge is to fund the Courthouse Construction Fund and the Criminal Justice Facilities Construction Fund.
- B. Since 1993, the City has been remitting this \$5 state-mandated surcharge to the county on a monthly basis, without collecting the cost of the surcharge from the parking violators.
- C. With the enactment of Senate Bill (SB) 1407, which took effect on January 1, 2009, the City is required to collect an additional \$3.00 state-mandated surcharge on parking offenses pursuant to Government Code section 70372. This surcharge is also to fund the Courthouse Construction Fund and the Criminal Justice Facilities Construction Fund.
- D. With the \$3 surcharge increase under SB 1407, the total amount of state-mandated penalty surcharge the City is now required to collect and remit to the County and State for every parking offense increases from \$5.00 to \$8.00.
- E. Therefore, the City desires to increase the amount of all City parking citations by \$8.00 to accommodate collection from parking violators of these state-mandated parking penalty surcharges imposed by Government Code sections 70372 and 76000.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The City Council hereby establishes an increase to the amount of a parking citation issued after March 15, 2009 by \$8.00 per citation, in accordance with Government Code sections 70372 and 76000 and as set forth in Exhibit A, attached to this resolution.
- Section 2. The City will collect and remit the \$8.00 surcharge on a monthly basis to the County Treasurer, who is required to transmit the funds to the State Controller within 45 days.

Section 3. Exhibit A is part of this resolution.

Section 4. The City Manager is authorized to decrease or increase the amount of the state-mandated parking penalty surcharge on City parking citations at such times and in such amounts as the state mandates the City to collect and remit such surcharges from time to time.


