At the request of Mr. John Pitman, I reviewed the plans and structural calculations due to the question about the 2"x10" roof joists spaced at 24" on center with LUS26 joist hanger. My comment on this issue is that the manufacturer's recommended minimum hanger size for 2"x10" is LUS28. It is necessary to add A34 framing anchors, Simpson or equal brand, at both sides of the 2"x10"s just above the LUS26 joist hanger. My findings revealed that the 2"x10" roof joists spaced at 24" on center is adequate for this project. However, it is recommended to provide 2"x10" bridging at mid-span.

I am confident that the above remedial measures should be adequate to reinforce the roof framing system of this project comparable in strength to conventionally spaced joists with right metal hanger support installed per manufacturer's specifications.
