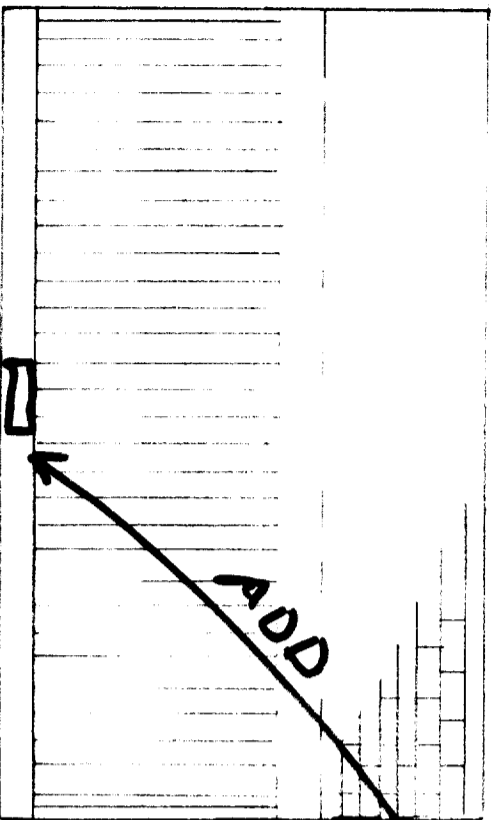
NORTH ELEVATION

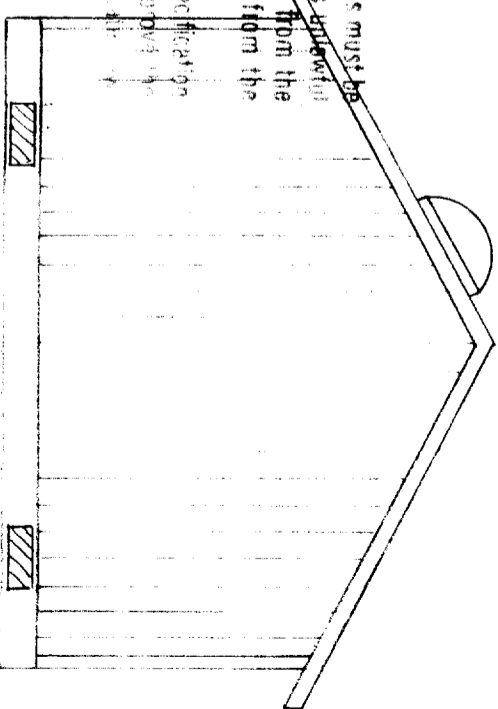

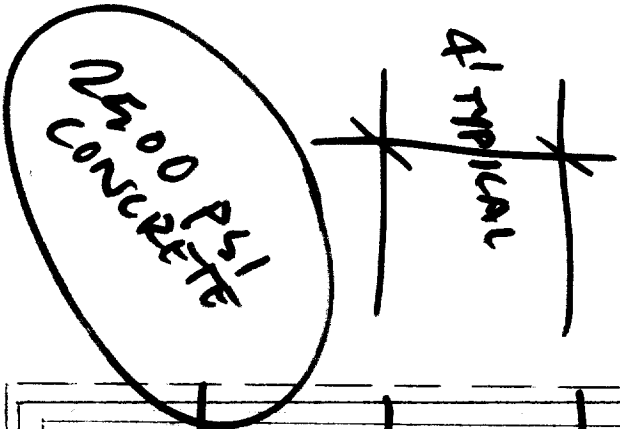
EAST ELEVATION

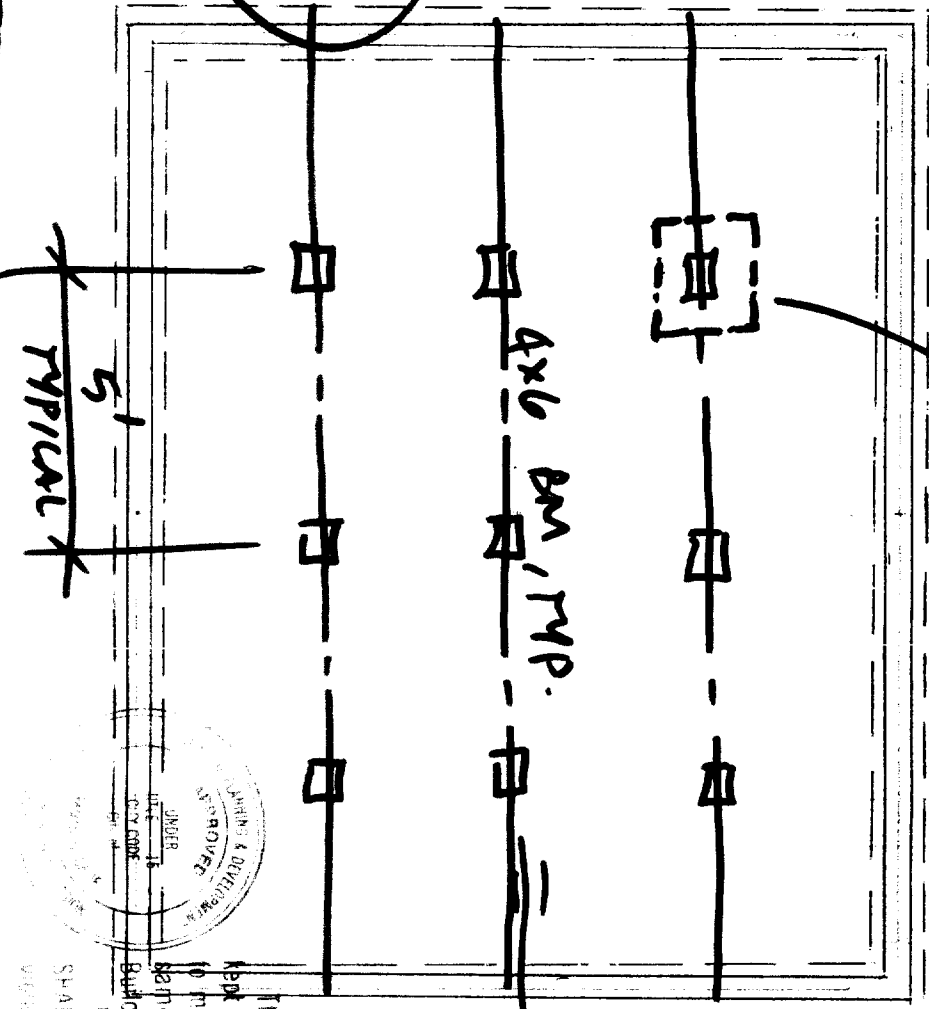

FOUNDATION PLAN



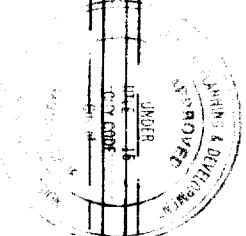
