SUBJECT: REPEALING THROUGH STREET RESOLUTION 88-325 AND APPROVING AN
UPDATED THROUGH STREET RESOLUTION

SUMMARY

This report recommends that the Transportation and Community Development Committee approve this report and refer it to the full City Council for adoption of the attached resolution which designates several roadways as through streets.

BACKGROUND INFORMATION

For improved traffic safety, whenever the speed limit on a street is 30 MPH or greater, the intersecting side streets are posted with stop signs making the street a through street. Through streets are important to the City transportation system because they provide improved circulation for greater volumes of traffic. Through streets are generally wider than residential streets and therefore have the capacity for these greater volumes. All of the street segments recommended in this report now carry, or will carry, a significant amount of traffic due to the residential and commercial development taking place along these segments and in the surrounding areas.

Recommended for inclusion on the through street resolution are the following streets:

1. CENTER PARKWAY is a south area street that has been extended south approximately 6000 feet to Bruceville Road. The extension creates a through street segment which extends from the North City Limits to Bruceville Road.

2. CALVINE ROAD is a south area street that has been extended a few hundred feet west of Suntrail Circle and now intersects Carlin Avenue. The extension creates a through street which extends from Bruceville Road to Carlin Road.
3. BRUCEVILLE ROAD, again in the south area, is a roadway which has been extended south from Timberlake Way to Cosumnes River Boulevard. It will be a major collector street. The extension creates a through street that extends from Valley Hi Drive to Calvine Road.
4. JACINTO ROAD is a new south area street which is to be a major collector for the City's southern most developments. The road origin is at the County maintained portion of Jacinto Road (east of Bruceville Road) and extends west to Calvine Road.
5. CALVINE ROAD is a new roadway which extends from Jacinto Road to Franklin Boulevard.

Exhibit A through E shows the locations of the recommended through streets.

The resolution recommended by this report includes streets that the City Council will consider under the speed limit resolution, which is being presented concurrently, in a separate item.

FINANCIAL DATA

No City funds are requested.

Funding for installation of necessary stop signs has been included in the operating budget of the Traffic Signs and Markings organization of the Transportation Division.

MBE/WBE

There is no MBE/WBE impact related to this matter.

POLICY CONSIDERATIONS


This recommended through street resolution has been revised in accordance with Section 25.40 of the Sacramento City Code, which authorizes the City Council to designate through streets.


RECOMMENDATIONS
