David Pelser, Solid Waste Division Manager, explained the report submitted to the Committee with examples of several packaging ordinances from other cities, designed to limit or reduce the use of excess plastic packaging which may have a negative environmental impact. He recommended that further consideration await recommendations from the City/County Solid Waste Advisory Committee (SWAC) in its Phase II report.

Committee Member Fargo questioned the success rate of the other cities. Mr. Pelser explained that the fast food restaurant are the focus of the program and participation is voluntary and not enforced.

The Committee received and filed the report.

Michael Davis, Planning and Development Director, briefed the Committee on the proposal to reduce the parking standards in the Central Business District by approximately 15%. Marty Van Duyn, Planning Director, was also available to answer questions. The reduction would help promote the increased use of alternative forms of transportation, thereby helping to control and improve air quality.


Working jointly with Public Works/Transportation and the Planning Commission, staff recommended that the Committee: 1.) schedule one or more Committee meetings to allow interested parties to review and submit testimony to the Committee on the recommendations; 2.) approve in concept, the short-term parking policy changes and direct staff to submit final implementing ordinances and resolutions to the City Council for approval and; 3.) direct staff to proceed with the process for developing a long-term public/private parking strategy.
