SKILLED LABORER (Water Dept.)

Mr. L. A. Ross, Skilled Laborer, Water Department, appeared before the Board, requesting the position classification of Skilled Laborer (Water Dept.) be changed to Water and Sewer Mechanic. He further requested that arrangements be made for a higher pay scale for Water and Sewer Mechanics than Skilled Laborer. After general discussion by the Board, the Secretary was instructed to obtain wage scales from private contractors employing men for similar work.
