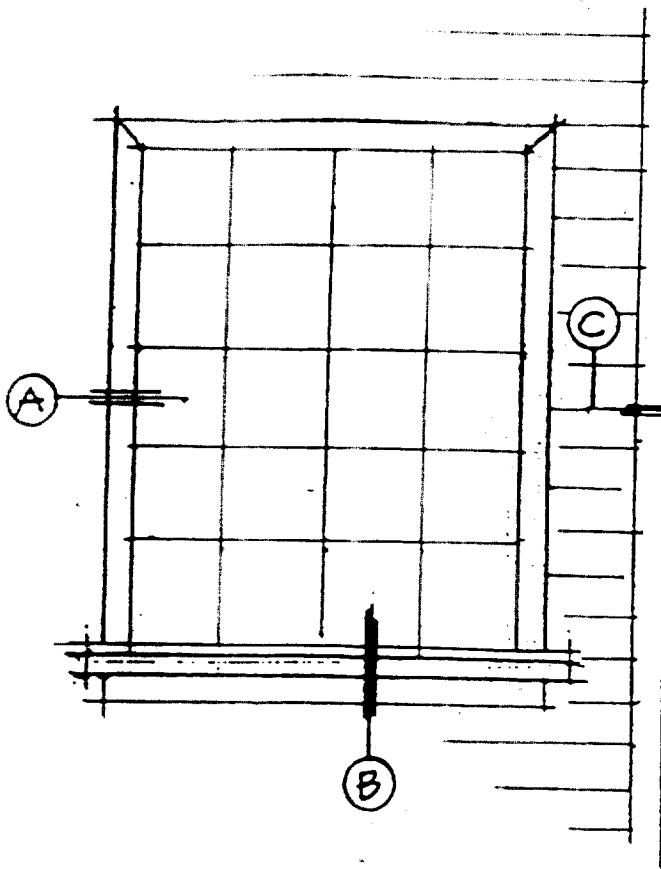

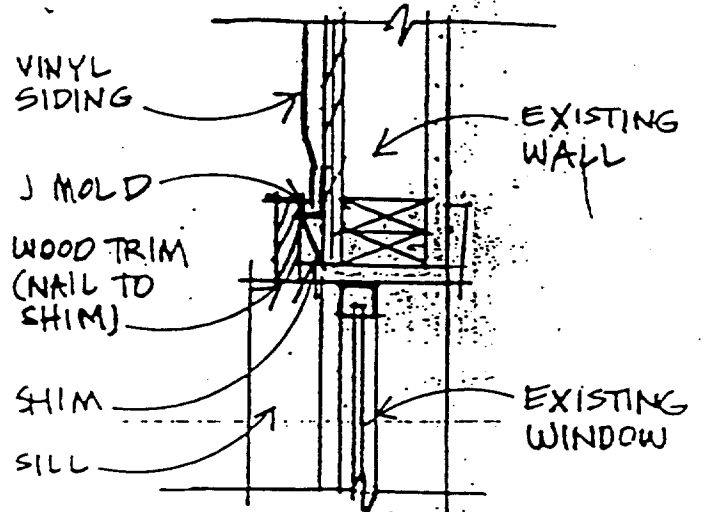

WINDOW ELEVATION



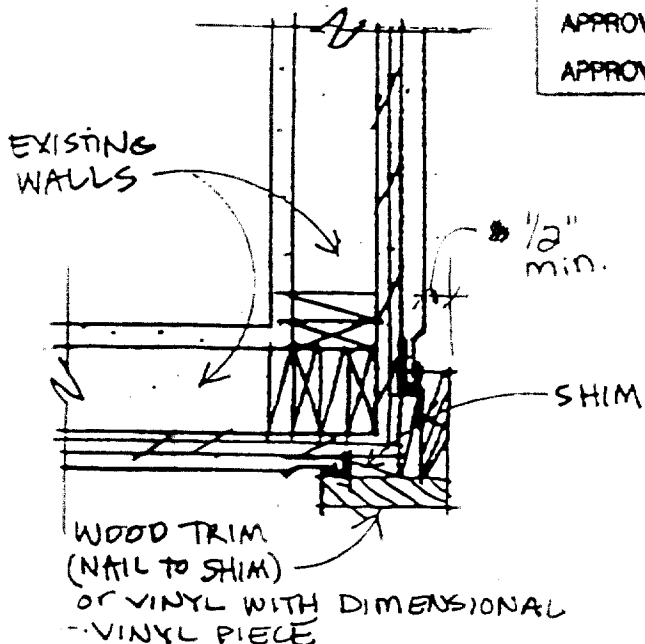

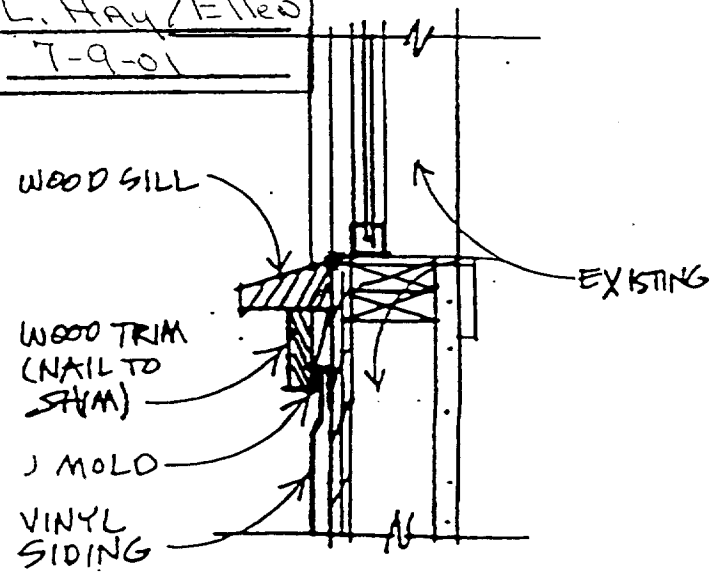

(C) CORNER

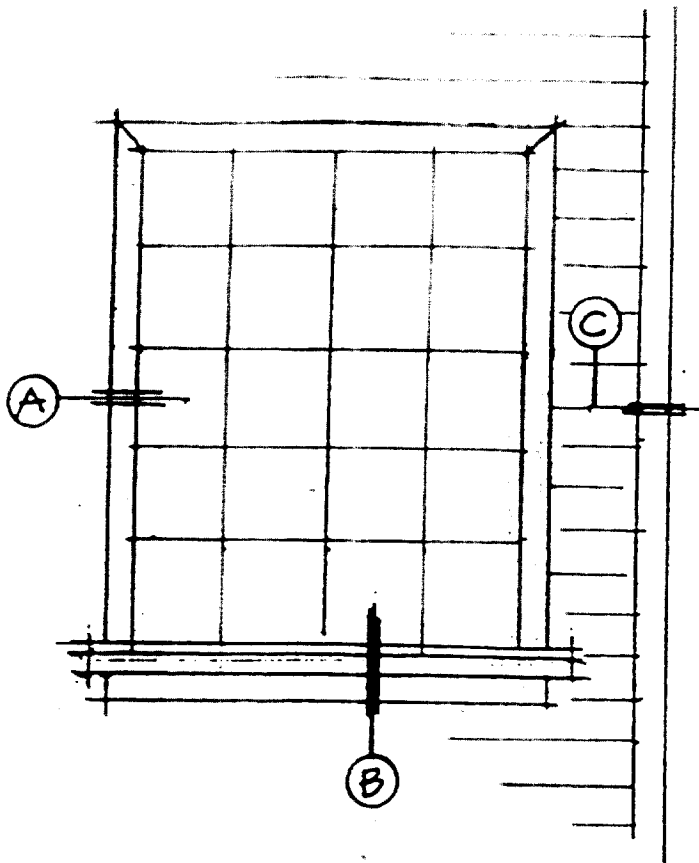

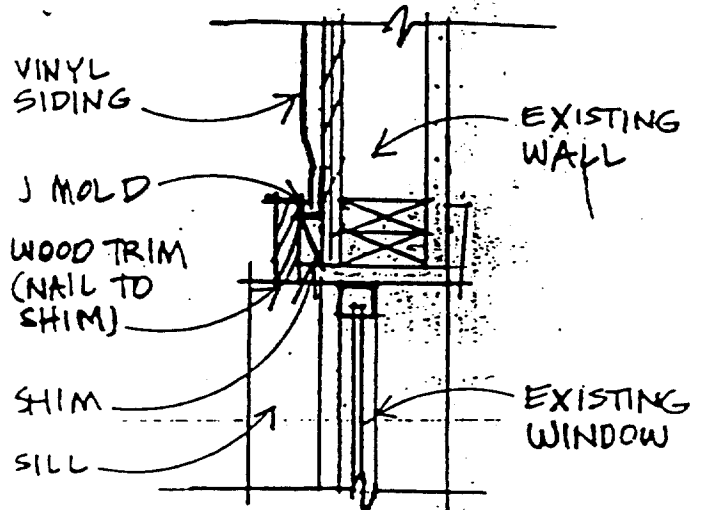

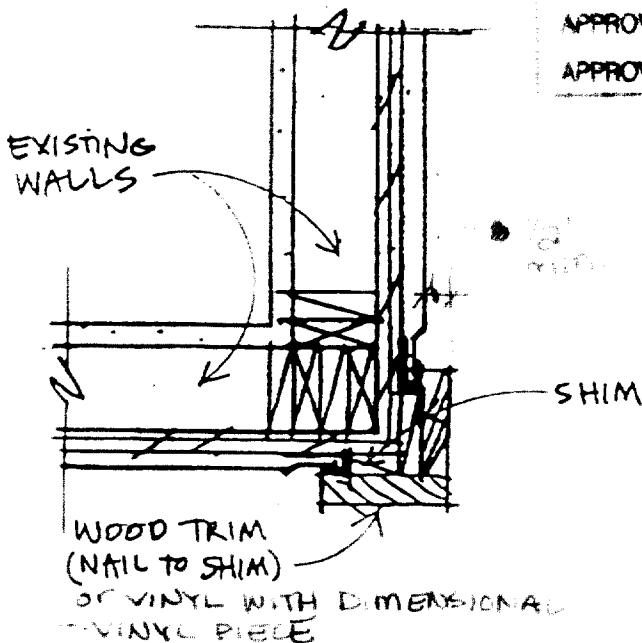
WINDOW ELEVATION



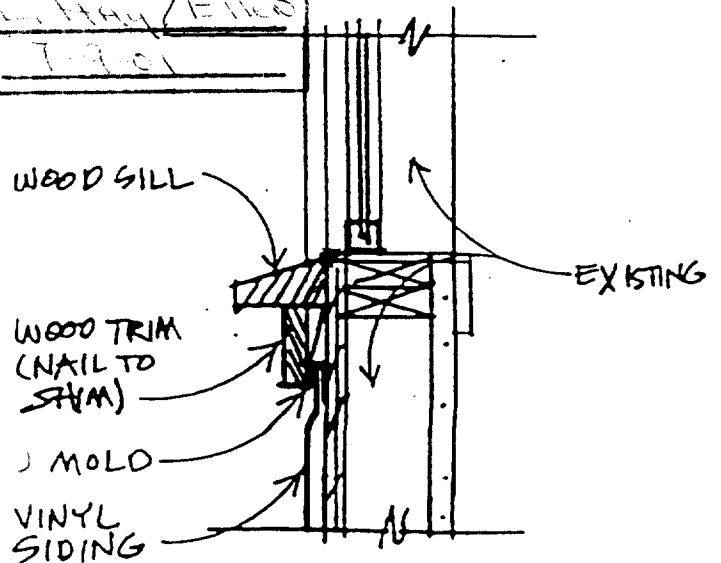
