RESOLUTION ACCEPTING RIGHT-OF-WAY DEED

WHEREAS, E. Hullin

has made, executed and delivered to the City of Sacramento a certain RIGHT-OF-WAY Deed, conveying to the City of Sacramento the following real property in the City of Sacramento, County of Sacramento, State of California, bounded and particularly described as follows:

Beginning at the intersection of the northerly production of the center line of 43rd Street of the City of Sacramento with the northerly line of Lot 99, as said lot is shown and so designated on the official "Plat of Glen Orchard Subdivision No. 1", filed in the office of the Recorder of Sacramento County in Book 10 of Maps, Map No. 51; thence from said point of beginning along the northerly boundary line of said Glen Orchard Subdivision No. 1 to the northeast corner of Lot 90 as shown on said "Plat of Glen Orchard Subdivision No. 1"; thence easterly along the northerly boundary line of Lot 1 as shown on the official plat of "Tract of Land owned by E. F. Aiken", recorded in the office of the Recorder of Sacramento County on January 25, 1901, in Book 4 of Maps, Map No. 8, to the northeast corner of said Lot 1 and the northwest corner of Coloma Terrace Unit No. 2, a plat of which is filed in the office of the Recorder of Sacramento County in Book 23 of Maps, Map No. 27; thence along the northerly boundary line of said Coloma Terrace Unit No. 2; South 87° 35' 25" East 43.74 feet; thence South 80° 40' 25" East 121.78 feet; thence South 73° 35' 25" East 430.32 feet and thence South 69° 35' 25" East 80.00 feet, to the northeast corner of said Coloma Terrace Unit No. 2 and the northwest corner of Coloma Terrace Unit No. 3, a plat of which is filed in the office of the Recorder of Sacramento County in Book 23 of Maps Map No. 21; thence along the northerly boundary line of said Coloma Terrace Unit No. 3, South 69° 35' 25" East 47.73 feet and thence South 56° 05' 46" East 398.70 feet to the northeast corner of said Coloma Terrace Unit No. 3; thence South 58° 45' 10" East 130.35 feet; thence South 60° 50' 04" East 100.08 feet; thence South 62° 32' 30" East 100.24 feet; thence South 63° 48' East 413.33 feet; thence South 60° 14' 20" East 385.35 feet and thence South 58° 42' 30" East 197.02 feet to a point on the southwesterly boundary line of property of Central Pacific Railway Company.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the said RIGHT-OF-WAY Deed be, and the same is, hereby accepted; the City Clerk being directed to attach certified copy hereof to the said RIGHT-OF-WAY Deed, and record same in the office of the Sacramento County Recorder.
