SUBJECT: APPLICATION FOR GRANT FROM CALIFORNIA STATE LIBRARY -  
LIBRARY SERVICES AND CONSTRUCTION ACT

SUMMARY

This is a request for approval to submit a Grant Application to the California State Library for \$160,828 to finance "The Reading Connection" project.

BACKGROUND

The California State Library offers an opportunity to all public libraries to apply for grant monies to provide help for the economically disadvantaged. This program will: (1) Increase student reading and improve reading skills; (2) Assist parents to become partners in their children's reading growth; and (3) Demonstrate the positive impact of increased public library and effective school library programs on student reading.

The Sacramento Public Library is a coparticipant with the Sacramento City Unified School District on this project.

FINANCIAL IMPACT

The Grant is for \$160,828 and would be available October 1, 1988 through September 30, 1989. The Grant is made available through the Library Services Construction Act awarded by the California State Library.




