SUBJECT: Resolutions Amending Resolution 77-348, Employer-Employee Relation Policy; and Resolution 80-415 relating to classifications and salary schedules.

SUMMARY

Reorganization of the Recreation Division of the Department of Community Services is in its final stages. This report outlines changes necessary to the completion of the reorganization, which fall under the jurisdiction of the City Council and recommends that the changes be approved.

BACKGROUND INFORMATION

Implementation of the third phase of the three phase reorganization plan for the Recreation Division has begun. Successful completion of the reorganization requires that certain classification changes be made - Some by the Civil Service Board and others by the City Council.

At its October 7, 1980 meeting the Civil Service Board approved classification title changes from the Recreation Supervisor and Senior Recreation Supervisor to Recreation Supervisor I and Recreation Supervisor II respectively. The Board also established a new class of Senior Recreation Supervisor.

In order to finalize the changes, Council approval is necessary to establish salary for the new class and to place the Recreation Supervisor I and Senior Recreation Supervisor classes in appropriate representation units. Resolutions are attached.

FINANCIAL DATA

No additional funds are required. Salary and benefits for the five new positions will cost approximately \$77,413 for the remaining six months of the current fiscal year. (Salary, \$1795 - \$2186 per month, and benefits 24%). Funds totaling approximately \$127,800 have been appropriated in the current budget.



A RESOLUTION AMENDING RESOLUTION NO. 80-415,
DATED JUNE 27, 1980, RELATING TO CLASSIFICATIONS
AND SALARY SCHEDULES

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. Section 1 of Resolution No. 80-415, adopted by the City Council on June 27, 1980, is hereby amended as follows:

1. The classification title "Recreation Supervisor" is changed to "Recreation Supervisor I."

2. The classification title "Senior Recreation Supervisor" is changed to "Recreation Supervisor II."

2. The new class code number for Recreation Supervisor I is 03262.

3. Effective immediately the salary schedule number, range number, and approximate monthly salary range for the classification of Senior Recreation Supervisor shall be as follows:
