WINDOW CLEANER

EMPLOYEES IN TREE DIVISION
Re: Outside Employment

The Board conducted a hearing with reference to a complaint that had been received, protesting the activities of the employees in the Tree Division, Park Department, whereby said employees have been accepting outside employment without permission of the Board.

Mr. Wilfred Messier, Tree Trimmer, Park Department, personally appeared before the Board for questioning with reference to his tree trimming activities.

In answer to questions by members of the Board, Mr. Messier stated that he had recently completed a contract with A. Teichert & Son for the removal of approximately 52 trees at 24th Street and Second Avenue for a total contract price of approximately \$5,000.00

Mr. Messier was further questioned by members of the Board with reference to his original application for a work permit, which was denied

June 11, 1953

by the Board on May 5, 1949, and the continuation of his tree removal activities subsequent to said denial.

Mr. Joseph Oakley, tree trimming contractor, personally appeared before the Board, protesting against the activities of the employees in the Tree Division, Park Department, stating that during the past four or five years, it has been necessary for him to compete in the tree removal business against said employees and that it is common knowledge that City equipment of all types is being used on this contract work.

Mr. Oakley also protested the employment of Leo R. Shands, as a Tree Trimmer in said department, contrary to the provisions of the City Charter, which require three years residence within the City of Sacramento. Mr. Oakley stated that Mr. Shands was employed on February 24, 1953, and was residing at 3244 $\frac{1}{2}$ -23rd Avenue, which is located outside the City Limits.

Mr. Oakley was thereupon excused.

After general discussion by members of the Board, Mr. Marty moved that the entire record with reference to the outside tree removal activities of the employees in the Tree Division, be submitted to the City Manager for his information and for disciplinary action in accordance with the rules and regulations restricting the holding of more than one salaried position; seconded by Mr. Wright and motion carried.

Mr. Wright thereupon moved that the Secretary be instructed to notify the Superintendent of the Park Department, to terminate the employment of Leo R. Shands, Tree Trimmer, Tree Division, for failure to qualify with three years residence as provided for in the City Charter; seconded by Mr. Marty and motion carried.

There being no further business, the Board adjourned at 9:40 P.M. to meet again at the Call of the Chair.
