CONTRACT **PROGRAMMER SERVICES** APPROVAL **OF** ADDENDUM TO CITY AGREEMENT NUMBER 99-082 WITH **COMPUTER** RESOURCES **GROUP FOR** ADDITIONAL CONSULTANT **COMPENSATION SERVICES** AND IN**AMOUNT OF** \$129,600, **BRINGING VENDOR'S** TOTAL **COMPENSATION TO \$489,302**

RECOMMENDATION:

This report recommends that the City Council approve an addendum to City Agreement Number 99-082, extending the term of the contract with Computer Resources Group through June 30, 2000, and increasing the compensation paid to Computer Resources Group by \$129,600.

SUMMARY:

This report recommends that the City Council approve an addendum to City Agreement number 99-082 with Computer Resources Group. Agreement Number 99-082 expired on December 31, 1999. This addendum would extend the contract through June 30, 2000, and provide for additional compensation in the amount of \$129,600. Six previous agreements with this vendor for closely related services total \$359,702. This addendum brings the total compensation to \$489,302.

COMMITTEE/COMMISSION ACTION:

None.

BACKGROUND INFORMATION:

- Computer Resources Group is one of three firms previously awarded contracts to provide programming services for the City's Year 2000 project.
- Under City Agreement Number 99-082, Computer Resources Group provided contractprogramming services to assist the Systems and Programming Division in the testing phase of its Year 2000 Project.
- Computer Resources Group will continue to provide Year 2000 programming assistance under the addendum to City Agreement Number 99-082, actively supporting the City's efforts to resolve any remaining Y2K issues. Computer Resources Group will also perform other programming services as required while the Technology Division turns its attention to work that was deferred while readying the City for Year 2000. In addition, Computer Resources Group will assist City programming staff in maintaining the Utilities Billing System (UCIS).

FINANCIAL CONSIDERATIONS:

The total compensation for the additional services to be provided under the addendum is \$129,600. Of that amount, \$89,600 is available from the Utilities and Public Works Departments since the services Computer Resources Group will provide include maintenance of the Utilities Billing System. It is recommended that the funds from the Utilities and Public Works Department be transferred to the Administrative Services Department Technology Division's budget line 101-130-1320-4258 from the following:

The Administrative Services Department Technology Division will fund the other \$40,000 of the total cost from its budget line 101-130-1320-4258.
