STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Roofing shall be 25-year laminated dimensional composition shingle.
2. No roof-mounted mechanical equipment is allowed.
3. Provide new plaster system with decorative trim and sills at windows. Provide decorative trim at doors and vents.
4. Provide new vinyl windows with grids.
5. Front entry door shall have a raised panel design.
6. Garage door shall have a raised panel design.
7. Gutters and downspouts shall be provided.
8. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
