

## 1. PURPOSE

- 1.1 To establish the policy and procedure for new City employees to receive reimbursement for household moving expenses.

## 2. POLICY

- 2.1 Allowances for the cost of transportation of household goods and personal effects applies to employment of Council officers and, with approval of the City Manager, to exempt management employees.
- 2.2 Maximum Allowances. The City of Sacramento will authorize payment of transportation charges computed on the basis of rates showing the carrier's lawfully published tariffs times the actual net weight for moving household goods and personal effects. The City will also authorize payment of up to four cents per pound times the actual net weight moved for accessorial service charges such as packing, unpacking, insurance, containers, etc. The amount of money authorized by the City for accessorial services shall not exceed the actual amount charged by the carrier.

In computing the amount of transportation charges to be authorized by the City, the actual net weight moved may not exceed 11,000 pounds for employees with immediate families, or 5,000 pounds for employees without immediate families. If the actual net weight moved exceeds these limitations, the amount payable by the City will be computed using the maximum allowable weight. All additional charges for transportation will be borne by the employee.

EXAMPLE: Employee with family moving 12,000 lbs (1,000 lbs over).

In computing the amount of accessorial service charges to be authorized by the City, the amount may not exceed four cents per pound times the actual net weight moved, such weight being limited to 11,000 pounds for employees with immediate families, or 5,000 pounds for employees without immediate families. All charges for accessorial services in excess of this limitation will be borne by the employee.

EXAMPLE: Employee with family moving 10,000 lbs, and authorizing containers, packing, unpacking, insurance and other accessorial service charges greater than the amount payable by the City.

2.3 The City will authorize payment of transportation charges computed on the basis of rates shown in the carrier's lawfully published tariff (within specified weight limits), plus up to four cents per pound in charges for additional services.

### 3. DEFINITIONS

3.1 "Immediate Family" is defined as any of the following named members of the employee's household at the time he reports for duty: spouse, children (including stepchildren and adopted children) unmarried and under twenty-one years of age, or dependent parents of the employee and of the employee's spouse.

3.2 "Household Goods and Personal Effects" is defined as personal property which may be transported legally in interstate commerce and which belongs to, and is in the possession of, an employee and his immediate family at the time shipment begins. The term includes household furnishings, equipment and appliances, furniture, clothing, books, and similar property. It does not include property which is for resale or disposal rather than for use by the employee or members of his immediate family; nor does it include such items as automobiles, station wagons, motorcycles and similar motor vehicles, airplanes, house trailers, boats, livestock, property belonging to any person other than the employee or his immediate family, or any property intended for use in conducting a business or other commercial enterprise.

### 4. PROCEDURE

4.1 Selection of Carrier. From the City's list of carriers (Appendix 5.1), select, if possible, a carrier from those in nearby locations so you can inspect the carrier's facilities. Contact a Sacramento representative of the carrier of your choice and request that he (1) arrange an inspection of the items to be shipped, and (2) submit a written estimate of the charges which will be applicable to your shipment. The carrier's written estimate should be submitted on a form which has been standardized by the moving industry and must include the mileage, estimated weight, and resultant tariff rate in cents per hundred pounds. In addition to the transportation rates,

the written estimate must contain rates for packing labor, unit cost of packing, appliance servicing and other accessorial charges, and rates for unpacking at destination. The question of overtime rates for transportation and for packing and unpacking labor should be discussed and such rates should be included in the written estimate if it is anticipated the carrier will incur overtime. The City will not reimburse you for any costs at overtime rates unless such overtime is for the City's convenience and is approved in advance.

- 4.2 Entering Into Contract With the Carrier. Once you have selected your carrier, submit a copy of the carrier's written estimate to the City's Support Services Division. A purchase order authorizing the transportation of your household goods and personal effects will be issued to the Sacramento representative of your carrier. It will be necessary for you to pay the City all charges which exceed the amount authorized by the City's policies as outlined above.
